## Daily Health Check

- Parents <u>do not</u> send students to school that are displaying COVID-19 symptoms
- Students must not be sent to school if the answer is "yes" to any of the questions listed below:
- Do I feel warm, have a fever or elevated temperature (100.4), or have the chills?
- Do I have a persistent cough, runny nose or sore throat?
- Have I recently had a loss of taste or smell?
- Has anyone in my household tested positive for COVID-19?
- Have I been in close, unprotected contact with anyone who has tested positive for COVID19 (spent longer than 15 minutes within 6 feet of someone who was sick with a fever and cough or confirmed/suspected of having COVID-19?)
- Am I feeling otherwise sick or ill today?
- Am I awaiting test results for COVID-19?
- Have I tested positive for COVID-19?
- Have I been told to self-quarantine or selfisolate by a doctor or District administrator?

## Practice Mask Protocol Now

- Parents have students practice wearing masks at home to get comfortable with wearing masks all day while on campus
- Students must wear masks at all times on the bus and on campus
- Students will not wear masks while eating
- Students will not wear masks while at <u>outdoor</u> <u>recess</u> and practicing social distancing at 6 feet apart

#### Is FSA Testing Optional?

- The state requires all students in 3<sup>rd</sup>/4<sup>th</sup>/5<sup>th</sup> to complete all FSA tests
- There is no provision from the state or district for parents to "opt" out of testing
- The district recognizes that the decision ultimately rests with the parents whether the child is sent to school on test dates
- There is no penalty for students who do not take the FSA tests
  - Please note that the FSA Writing test is a part of the final score for 4<sup>th</sup> & 5<sup>th</sup> grade ELA FSA
- Students who do not take the FSA tests <u>can</u> be promoted using the other district "good cause" criteria since they will not have a FSA test score

#### 15. What if my student does not take a State assessment exam at all this school year?

#### <The answer to this question depends on the grade level or course(s) of the student.>

- a. For students in Grade 3, the absence of an FSA ELA score will result in "Good Cause" criteria being applied to determine if the student is promoted to Grade 4 according to Florida Statute Section 1008.25(5)(b), F.S. The Florida Department of Education has announced that Grade 3 FSA ELA scores will be returned to the districts no later than June 30, 2021. Students who score a Level 1 will be prioritized for review by the school's Collaborative Problem-Solving Team for grade placement and additional support.
- b. For students in grades 4-5, promotion decisions will be based on SBBC policy 6000.1 (<u>https://www.browardschools.com/progressionplan</u>). In short, local assessments, performance on diagnostic assessments, and teacher issued grades will determine if a student is promoted.

For students in grade 6-8 In short, promotion decisions will be based on SBBC policy 6000.1 (<u>https://www.browardschools.com/progressionplan</u>). In short, local assessments, performance on diagnostic assessments, teacher issued grades and the passing of required courses will determine if a student is promoted.

## Arrival Procedures

- All students <u>MUST</u> arrive to school by <u>9:30am</u> on testing dates
- Students will receive a grab & go breakfast and will report directly to their classrooms
- Students will begin testing promptly at 9:35am
- Students arriving by car after 9:35am will be sent home with parents

- Students arriving by bus after 9:35am will be placed in an alternate location and will work on review assignments with a substitute teacher
- At-home learners coming in on testing dates do not need to bring their laptops to school on testing dates
- Students should bring a jacket and water bottle on testing dates

#### Testing Conditions

- Students will test with their classroom teacher
- Students with an IEP or 504 plan will test in the small group setting as indicated in their respective IEP or 504 plan
- Students will be spaced in all testing locations according to district and CDC physical distancing guidelines
- If capacity is met in the classroom, students will test in another room with a NEE teacher to adhere to physical distancing guidelines
- Students will use the restroom before testing
- Teachers will call the office if there are any student emergency restroom needs during testing

## Lunch Procedures

- The bell schedule has been adjusted to ensure students will be spaced in the cafeteria and additional lunch seating areas according district and CDC physical distancing guidelines
- Lunch is free for all students

#### Post Testing Instruction

 Students will work on paper-based review activities after testing is complete

#### After Testing is Complete

#### EARLY SIGN-OUT AFTER TESTING

- Parents can pick students up early after testing
- The parent/adult picking up the child must be listed on the emergency contact card and must arrive with appropriate ID to sign out the student
- Let your child's teacher know in advance if you plan to pick up the student early after testing
  - 3<sup>rd</sup> Grade April 13<sup>th</sup>/14<sup>th</sup> Plan to pick up after 12:15pm
  - 4<sup>th</sup>/5<sup>th</sup> April 20<sup>th</sup> or 21<sup>st</sup> Plan to pick up after 12:30 pm
  - 504 Plan and Students with an IEP may have extended time for testing, please call the office after 12:15pm to get an expected completion time
- Parents arriving for early sign out must arrive to the office by 2:50pm
  STUDENTS REMAINING ON CAMPUS ALL DAY
- Student will work on paper-based review activities
- Let your child's teacher know in advance if your child will be a car rider or bus rider on testing dates

## Dismissal

- Students will be dismissed by bus, car or after care based on the information the teacher received from parents
- Check virtual counselor for bus information before the first day of testing
- If you have questions about the bus stop or bus number call the office by Friday, April 9<sup>th</sup> to confirm bus information
- Be sure your child knows how they are going home on test dates and bus information if applicable

#### Before/After Care

- At-home students who will stay in school for the entire day on testing dates and will need Before/After Care services must:
  - Register using the link on the Nova Eisenhower website
  - Email Mrs. Janice Brown, After Care Supervisor, to set up a time to arrange payment for the specific dates the student will be on campus
  - Before Care hours 7:00am 9:00am
  - After Care hours 3:30pm 6:00pm
