

Safety Updates

Title 1 Updates

- Ms. McKeever announced the upcoming Parent Training on Financial Literacy to take place on November 14, 2024 @ 7:00pm and provided a flyer with registration information.
- Ms. McKeever invited parents and guardians to visit the mobile unit which was present, to be made aware of available resources that could be used at home with students and returned to Morrow.
- Ms. McKeever brought parents and guardians up to date on the 5000 Role Model program which targets boys in the 4th and 5th grades and encourages ways to develop character traits upheld by the school (honesty, respect, etc)
- Ms. McKeever informed parents and guardians of the Induction Ceremony that took place on November 12, 2024 and the 17 members that were inducted into the program.
- Ms. McKeever reminded parents of the 21st Century Aftercare Program and its focus on academics and project-based learning activities as well as the various clubs that have been created based on student interest in which the students participate on Fridays (arts, science, percussion, science etc.)
- Ms. McKeever reminded parents to complete the Title 1 Parent Survey and encouraged input.

Upcoming Assessment Updates

- Ms. Reid reviewed how Morrow monitors progress of students to reflect growth through the grade-level assessments, and reviewed the upcoming dates and types of assessments.
- Assessment Dates: PM 2 (Progress Monitoring 2)
- VPK – 2nd – STAR Assessment—Computer Adaptive
- Grades 3 – 10- Cambion—Computer Adaptive

- 3rd – 5th Grade Reading—December 12, 2024
- 3rd – 5th Grade Mathematics—December 13, 2024
- K – 2nd Grade Reading December 9, 2024
- K—2nd Grade Math December 11, 2024
- Ms. Reid explained that ‘computer adaptive’ means the test adjusts based on students’ performance and tests them on their level.
- Ms. Reid encouraged parents to enforce appropriate rest times and appropriate diet so that students can perform at their best.
- Ms. Reid encouraged parents to bring students to school on time and emphasized its importance.
- Ms. Reid invited questions, comments, and input.

Principal Updates


