Application and Enrollment Information**

**Who:**

- Children who turn 4 by September 1, 2018 (born Sept. 2, 2013 – Sept. 1, 2014) or who qualify for a 2018-2019 VPK Certificate
- Family must live within the school's attendance boundary
- Children who have an academic need

**What:**

- 6-hour, full-day early learning program, **8:00 a.m. – 2:00 p.m.**, Monday - Friday
- Program begins first day of school, August 15, 2018
- Students qualify based on academic need
- District reserves the right to cancel a class due to funding or enrollment issues

- February 20 – March 20, 2018 - Application period
- School accepts applications during regular school hours
- All documents must be submitted by the March 20<sup>th</sup> deadline to be considered for enrollment
- **April 23<sup>rd</sup> – 27<sup>th</sup>, 2018 - NOTIFICATION school notifies parents of enrollment status**

**How:**

Step 1. Complete the **Broward Schools VPK Pre-application** online at <http://ece.browardschools.com>

Step 2. Visit the school to receive the VPK/Enrichment (Title I Supported) Registration Packet

Step 3. Bring the following documents to the school **by 3:00 p.m., March 20, 2018.**

1. Copy of Pre-application confirmation email
2. VPK Program Protocols
3. Parent Questionnaire
4. Preschool Medical Record
5. Student Registration Form – (if provided by school)
6. Emergency Contact Form – (if provided by school)
7. Copy of child's birth certificate (or other proof of child's age)

Step 4. Sign up for a screening date/time at the school

Step 5. Apply for you VPK Certificate of Eligibility.

- To apply online for your child's VPK Certificate, visit (<https://familyservices.floridaearlylearning.com/>) OR for parents who do not have access to a computer, please call The Early Learning Coalition at 954-377-2188 for assistance.
- **Note:** If selected for the program, you will need to provide your child's original VPK Certificate of Eligibility no later than **May 11, 2018.**
- **Note:** The VPK/Enrichment Program does **NOT** provide transportation.
