Provide weather stripping/repair or replace screen door.</p> <p>CODE REFERENCE: 64E-11.003(5)(f). Effective measures shall be taken to control the presence of pests in the food establishment. Unless otherwise approved, live animals shall not be allowed.</p>
<p>Violation #54. Garbage &amp; refuse disposal Garbage/dumpster not cleaned frequently, has buildup of soil/food conditions attracting insects/animals. Maintain garbage container/dumpster clean and vermin free.</p> <p>Dumpster drain plug missing, wastewater draining out of dumpster. Replace drain plug</p> <p>CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
<p>Violation #55. Facilities installed, maintained, &amp; clean Ceiling tiles missing/bulging in break room. Repair/replace ceiling tiles.</p> <p>CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
