I. Welcome & Bylaws

Meeting was called to order at 3:04 p.m.

II. Reading of the Minutes:

Minutes were read by Mrs. Tardieu. Minutes were approved by Ms. Moore and second by Ms. Marcel.

III. Principal's Report:

Ms. Porter shared the following information:

- Game Bus will be coming out as an incentive for students that made growth on the FAST PM3
- Budget conference will be held on May 12th, not many changes to the budget
- Budget presentation at next meeting to break down where all the money goes to see how money will be spent

IV. Budget Update:

Mrs. Porter shared that there is \$6,591.81 in the School Accountability Funds.

V. Florida School Recognition Funds (A+ Funds) Missed Payments

- The SAC committee was notified that there was an error with the distribution of the A+ funds. Everyone that received A+ funds was technically overpaid. To avoid requiring the staff to return funds, the school is requesting to use some of the balance in SAC accountability and A+ funds to cover the error. \$254.08 would come from the A+ Funds and \$796.42 would come from the School Accountability Funds.
- Mrs. Tardieu motioned to vote to use \$254.08 from the A+ funds and 796.42 from the Accountability Funds.
- The committee discussed and voted to use the A+ Funds -\$254.08 and Accountability Funds-\$796.42 to correct the error.

Nob Hill E.S. still has 5 incidents that fit this criterion. We have started using the Suite 360 lessons.

Officer Yeung shared that she has been working with Broward County Schools Environmental Safety & Traffic Control to fix the flow of traffic at arrival and dismissal.

- Do Not Park at the Exit Gates and Left Turn Only During School Hours signs with listed times will be posted
