School Advisory Council Minutes
January 26, 2022

I. Welcome:

Meeting was called to order at 3:05 p.m.

II. Reading of the Minutes:

Minutes were read by Mrs. Tardieu. Minutes were approved by Ms. Reinman and second by Mrs. Haggerty.

III. Principal's Report:

Ms. Porter shared that it has been a busy start to the school year, in regards to positive Covid cases. The custodians have been using E-misters and making sure the classrooms are properly sanitized. Students just completed the second round of diagnostic for the school year. The students did a great job, our numbers were higher than the district and other schools in our cadre. Morning tutoring still available Monday-Thursday. Teachers are available to tutor students in every grade level. Positions are available for ESPs and a custodian would be starting on Feb. 14th. She also mentioned that PTA has agreed to help with funds to purchase Promethean Boards for the teachers. This would be a 2–3 year process. We continue to do our Code Red Drills every month but this month the school had an evacuation drill. Teachers and students evacuated to the soccer field. We are working with district to pave sidewalk for special needs students. Career Day will be on Friday, March 11th. We are looking for volunteers to come out and share their expertise with our students.

IV. Budget Update

Mrs. Most shared that we still have \$4890.47 in the school accountability fund. SAC voted to use the funds to purchase Promethean Boards. Left over funds may be used on items based on teacher request. (i.e. math kits, rugs, etc.)

V. Title 1 Report

Mrs. Most shared that family night was held virtually on January 12th. Our partners Mathnasium did a great presentation for the students. We only had 20 students attend. This was a much smaller turn out than our first family night but overall, it was a fun night. Instructional materials funds placed. Spring tutoring started on Monday, January 24th and will end on March 16th. Only four teachers willing to tutor, so we were only able to have 25 students. Students were strategically selected to attend tutoring.

VI. School Improvement Plan

Mrs. Most shared that the Mid-Year Review was completed. Parent input is encouraged. We are trying to support students through pull-out/push-in services throughout the day. She also mentioned that we have six teachers providing the pull-out/push-in services.

VII. School Environmental Safety Incident Reporting (SESIR)

The School Environmental Safety Incident Reporting (SESIR) System currently collected data on incidents of crime, violence, and disruptive behaviors on school grounds, on school transportation, and at off-campus, school-sponsored events, during any 24 hours, 365 days per year and Nob Hill E.S. still has 0 incidents that fit this criterion. Mrs. Porter shared that no incidents reported due to the warm environment and teachers working on improving student behaviors.
