### Safety Updates

  - Ability to quietly communicate with bystanders on campus
- Codes conducted regularly and safe team meets to reflect on procedures and outcomes of code following the drill.

# **COVID Updates**

- Positive cases reported on campus for students and staff
- Continued safety precautions are put in place
- Quarantines students have live access to classrooms as well as work packets available for quarantined students.
- All vendors and visitors must always wear a face mask when on campus.
- Students and staff are strongly encouraged to wear face masks, but it is not mandatory.
- On campus vaccinations put on paused by the Health Department, we will have rescheduled dates. February 11<sup>th</sup> is canceled as of now.

### School Wide Updates
