Review of 2023-2024 Parent & Family Engagement Survey Results.

- 81% Approved
- 87 Responses (At least 10% of parents must respond to survey; 13% responded)
- Parents say that they receive information from their child’s school- 31% strongly agree, majority of parent either agree or disagree.
- Parents receive information about the Florida Standards- Some parents strongly disagree, other parents said yes. More information about Florida standards will be shared in Literacy Night.
- Information on how your child score on the state test- 40% strongly agree, 44% agree.

Review of the 2024-2025 Parent & Family Engagement Plan

- Parents suggested adding additional Literacy and Curriculum Nights and Technology Nights to review technology resources to support students at home.
- A parent asked where to find the Title One documents. All current documents are found in the Title I page in the school website.
- The group reviewed the current and future PFEP and provided feedback. They suggested to add a Technology Night to the 24-25 PFEP to gain insights on the various applications students use throughout the school year.

School & Parent Compact Review & Feedback
