Do not pack commercially made complements in contact with RTE food. CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.</p>
<p>Violation #51. Plumbing installed; proper backflow devices Somat floor drain overflowing. Unclog/repair floor drain to allow for proper drainage.
