- **Pre-K Parent** (if applicable – parent or certified teacher)
- **SAF Chair** (or designee, must be a parent of a student at the school; cannot be a school employee)
- **Teacher Representative:** Mr. Carol

Parent Input

Ms. Jones opened the floor for parental input regarding the School Improvement Plan. Parents suggested the following initiatives:

- **Mentorship Programs:** Parents expressed interest in establishing in-school mentorship programs that include student incentives.
- Ms. Beavers informed attendees about two mentoring initiatives starting at the school. One of these programs is led by community partner Prevention Central, which also offers additional community services.

2024-2025 State and District Assessments Overview

Ms. Jones reviewed the key assessments used to measure student achievement:

- **Star Math, Star Literacy Reading, and FAST Assessments:** Administered three times a year (beginning, middle, end) to monitor student progress in meeting Florida's educational standards.
- **Use of Results:** Data informs school and district grades and supports tailored interventions for student needs.
- **Mandated Testing Limit:** Broward County schools operate within the 5% mandated testing cap.
- **Promotion Requirements:** Students must achieve a **Level 2** to qualify for promotion.

Parents were reminded they could access their child's test results and progress via the FOCUS Parent Portal.

Accountability Funds

- **Total Available Funds:** \$48,321.34
- **Governance:** Use of these funds is managed by the SAC Composition.
