

**SCHOOL BOARD OF BROWARD COUNTY, FLORIDA
STATEMENT OF PROVISIONARY DOMICILE**

In accordance with Broward County School Board (SBBC) Policy 5.1, a student shall attend the school in the boundary in which the parent(s), as defined in SBBC Policy 5.1, reside. It is the responsibility of the parent(s) to provide proper documentation to verify their residence.

When a family is "in transition" and resides with another person(s) due to loss of housing, economic hardship, or a similar reason; is living in motels, hotels, travel trailer parks, or camping grounds due to the lack of alternative adequate accommodations; is living in emergency or transitional shelters; is abandoned in hospitals; or is awaiting foster care placement (F.S. 1003.01 (12) a.); then this family is considered a family in transition and is eligible for services under the McKinney-Vento Homeless Education Act. The Provisional Domicile form is not applicable to this population. The student must be enrolled immediately and be referred to the school's homeless liaison.

A family may claim Provisional Domicile for reasons other than those addressed under the McKinney-Vento Homeless Education Act, as defined in SBBC Policy 5.1. Provisional Domicile is subject to approval by the school principal and shall be renewed every 30 calendar days.

Florida Statute §837.06 provides that whoever knowingly makes a false statement in writing with the intent to mislead a public servant in the performance of his or her official duty shall be guilty of a misdemeanor of the second degree. Additionally, a person who knowingly makes a false declaration under penalties of perjury is guilty of the crime of perjury by false written declaration, a felony of the third degree.

I agree to immediately notify the school (within 10 days) in writing, of any future changes in address or living arrangements of this student(s). Under penalty of perjury, I hereby declare that I have read this document and the above facts are true and correct.
