<p>Violation #21. Hot holding temperatures Hot TCS food (sweet potato fries) tested _100__F, not held at 135F or above. Hold hot foods at 135F or above. Corrected onsite by PIC, fries were placed in oven to reheat. Food later tested to 165 F.</p> <p>CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.</p>
<p>Violation #45. Single-use/single-service articles: stored & used Single-use item (cups and lids) stored directly on floor. Store single-use items 6 inches off floor. Corrected onsite by food worker. CODE REFERENCE: 64E-11.003(4). Single-service/Single-use articles must be properly stored and protected to prevent possible contamination. Discard items after use.</p>
<p>Violation #54. Garbage & refuse disposal Garbage container/dumpster not kept covered with tight fitted lids/covers/doors. Keep garbage container/dumpster closed, provide tight fitted lids.</p> <p>CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.</p>
<p>Violation #55. Facilities installed, maintained, & clean Ceiling tiles stained in laundry room. Replace/replace ceiling tiles.</p> <p>CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
