CORAL SPRINGS HIGH SCHOOL STUDENT PARKING AND DRIVING POLICIES

(PARENTS AND STUDENTS WILL INITIAL EACH LINE ON THIS FORM)

- A. To obtain a CSHS Parking Decal, students must have: a valid Florida Drivers License, a valid vehicle registration, verified insurance on the registered auto, and a 2.00 weighted GPA. CSHS administration reserves the right to ask for updated verification at any time. If the aforementioned criteria are not met, CSHS will revoke the decal immediately. Furthermore, if a student’s weighted GPA is below 2.00 for any marking period, his/her decal maybe revoked. _____/_____
- B. If a decal is revoked for any reason, the decal fee will not be refunded. _____/_____
- C. Students drivers will not exceed 10 mph, squeal tires, play “systems” loudly (in violation of the city noise ordinance), back into parking spaces, angle park, or drive in any manner that is hazardous. Violation of any of these policies will result in revocation of the decal. _____/_____
- D. Per SBBC Policy 5307 “The SBBC shall not be responsible for damage to automobiles or other vehicles which are parked or operated on school property.” Students are to report any damage to their vehicles to the office. Furthermore, CSHS is not responsible for any property in any vehicle. Do not leave valuables in the car. _____/_____
- E. Under no circumstances are students to park in any faculty lot or in front of the school. All student drivers will park in their assigned locations. Violation of this policy will result in immediate revocation of the student’s parking decal. _____/_____
- F. Students will not go to the parking lot, sit in any parked auto, or use their auto as a locker. Administrative consequences and revocation of the parking decal are direct and immediate responses. _____/_____
- G. Student will not use their auto to leave campus without direct administrative approval. If a student is enrolled in an off-campus program, s/he will provide documentation to leave campus. Failure to provide documentation will result in loss of the decal. _____/_____
- H. All vehicles on campus are subject to search. If for any reason, security chooses to search a vehicle, the student driver will comply. _____/_____
- I. Any decal that is transferred or resold will be forfeited and both drivers denied access to student parking. _____/_____
- J. Parking and student operation of a vehicle on campus is a privilege not a guarantee. Drivers who do not comply with stated “Parking and Driving Policies” are subject to:
 - i. Suspension of driving privilege
 - ii. Revocation of driving privilege
 - iii. Citation by Coral Springs Police Department
 - iv. Removal of the student’s vehicle by tow truck (at owner’s expense)
 - v. Attachment of the “Denver Boot” to immobilize the vehicle
 - vi. Attachment of a warning decal to the side window(s) _____/_____
- K. If a decal is lost/stolen, a replacement decal must be purchased immediately. _____/_____
- L. Students who are repeatedly tardy (three or more times) and/or unexcused absent will have their decal revoked. Driving is a privilege and it requires responsibility. _____/_____
- M. Students who receive repeated disciplinary referrals are subject to having their decals revoked by their administrator. _____/_____
- N. Any student parking illegally or violating any parking rules is not eligible to purchase a decal.
