STUDENT PARKING AND DRIVING POLICIES

PARENTS AND STUDENTS WILL INITIAL EACH LINE ON THIS FORM

- Α. To obtain a CSHS Parking Decal, students must have: a valid Florida Driver's License, a valid vehicle registration, verified insurance on the registered auto, and a 2.00 unweighted GPA, CSHS administration reserves the right to ask for updated verification at any time. If the aforementioned criteria are not met, CSHS will revoke the parking decal immediately. Furthermore, if a student's unweighted GPA is below 2.00 for any marking period, his/her parking decal may be revoked.
- B. If a parking decal is revoked for any reason, the fee will not be refunded.
- C. Student drivers will not exceed 10 mph. squeal tires, play "systems" loudly (in violation with the city noise ordinance), back into parking spaces, angle park, or drive in any manner that is hazardous. Violation of any of these policies will result in revocation of the parking decal - /
- D. Per SBBC Policy 5307 "The SBBC shall not be responsible for damage to automobiles or other vehicles which are parked or operated on school property." Students are to report any damage to their vehicles to the office. Furthermore. CSHS is not responsible for any property in any vehicle. **DO NOT LEAVE VALUABLES IN THE CAR**. /
- E. Under no circumstances are students to park in any faculty lot or in front of the school. All student drivers will park in their assigned locations. Violation of this policy will result in immediate revocation of the student's parking decal.
- Students will not go to the parking lot, sit in any parked vehicle, or use their vehicle as a locker. Administrative F. consequences and revocation of the parking decal will be immediate.
- G. Student will not use their vehicle to leave campus without direct administrative approval. If a student is enrolled in an off- campus program, she/he will provide documentation to leave campus. Failure to provide documentation will result in loss of the parking decal.
- H. All vehicles on campus are subject to search. If for any reason, security chooses to search a vehicle, the student driver will comply. _____/_
- Any parking decal that is transferred or resold will be forfeited and both drivers denied access to student I. parking. /
- Parking and student operation of a vehicle on campus is a privilege not a guarantee. Drivers who do not comply with J stated "Parking and Driving Policies" are subject to:
 - i. Suspension of driving privilege
 - Revocation of driving privilege ii.
 - Citation by Coral Springs Police Department iii.
 - Removal of the student's vehicle by tow truck (at owner's expense) iv
 - Attachment of the "Denver Boot" to immobilize the vehicle v
- K. If a decal is lost/stolen, a replacement decal must be purchased immediately.
- Students who have 5 or more tardies and/or unexcused absences per guarter may have their decal L. revoked.
- M. Any student parking llegally or violating any parking rules is not eligible to purchase a decal. /
