<p>Violation #21. Hot holding temperatures Hot TCS food (beans-serving line) tested 100F, not held at 135F or above. Removed from serving line and reheated. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.</p>
