School District Funding

- Based on forecasted enrollment
 - o 1,038 students going down to 1,011 means one class less
 - When you don't meet the requirements, they take the money back
 - Delimit one position
 - No academic extras
 - o No extra monies

Policy 5.5

- All cameras on!
 - o Teachers are in an uphill battle to get students to comply
 - \circ $\;$ Better teacher-teacher relationships can aid in the reduction of backlash
 - \circ $\;$ Please have a conversation with your children to turn their cameras on
 - o Cameras help prevent students from not paying attention

Cheating Software

- Encourage your kids to do the right thing. No plagiarism, etc.
- District Advisory Meeting (DAC)
 - Mr. Runcie's focus was on signage, water fountains, and BCPS work.
 - o Problems with retrofitting of water fountains of no touch fountains
 - \circ At Westpine, three are being fitted out of 8 at \$1,550 a piece

COVID-19 School Information

- 900 plus cases in Broward Schools
 - 12 cases occurred in the schools
- Due to the pandemic, 20,000 students are failing versus the normal 8,000
 - o It's going to take a community effort to less the load
 - Moving to face-to-face instruction
 - There's a big district push for face-to-face instruction for non-engaged and failing students
 - \circ $\;$ Vaccinations are needed since less than 6 feet of social distance would be necessary
 - Until then, teachers have Polycom cameras that follow the teacher around and allow for some normalcy for those in the classroom while those at home can still learn.
- The DAC says only 25% of students have come back to campus and want to push for 60% now
 - Westpine's target is less than 60% to keep up with social distancing, etc.
 - Mr. Runcie has been speaking with Governor DeSantis about putting education workers on the forefront for the vaccinations
- For FSA testing, maybe a rotating schedule will work or stretching the testing schedule
- 8,650 less student are now enrolled in Broward County Public Schools
