Principal's Report ~ Ms. Robinson

Ms. Robinson welcomed staff and guests to the meeting.

Guidance Counselor ~ We now have a full time Guidance Counselor assigned to our school from Davie Elementary. Her name is Ms. Nancy Sullivan. (Note: Ms. Sullivan spoke on her background and credentials).

School Yearbook ~ Announcement made that this is the first time in recent years that the school will have a yearbook. Ms. Parish-Williams is Chairperson. Flyers were placed in the teacher's mailbox to go home.

Academic Focus ~ School City assessments will start at the end of the month. This will be for 2nd grade-5th grade. More information is forthcoming from Mr. Campo.

Program Consulting Group (PCU) ~ The school was selected for this program which offers five tutors for our after-school program. They will be working with Centry 21 Program and provide one-on-one tutoring.

School Environmental Safety Incident Reporting (SEIR) Data ~ As of 09/28/21, there were no reports or incidents.

Learning Gains ~ Ms. Mocombe

Student Highlight for Hispanic Heritage Month ~ Hailey Escobar 4th grade.

School Improvement Plan ~ Ms. Phillips

For the 2021-2022 school year, we will focus on Reading for students with disabilities (SWD), in grades 3rd-5th. Based on school data, Every Student Succeed Act (ESSA), Federal Index is 36% of SDW. Our goal is to show an increase from 36% to 41% or higher, measured by 2022 FSA Assessment and ESSA Federal Index. By Spring, our subgroup will increase to 41 percent or higher as measured by the ESSA Federal index. (Note: Information taken from Ppt presentation).

Ms. Phillips stated 42 students have been identified as ESE: three gifted; half in intermediate grades.
