This staff member impacts 31 ELL students per day delivering support and intervention programs. This staff member serves as liaison between the school and ELL community.

Guidance, registrar, and teachers are responsible for helping to identify homeless students and referring them to our Homeless liaison who then refers the family to the Homeless Education program offered by the district. The purpose of the Homeless Education Program is to identify homeless students, remove barriers to their education, including school enrollment, and provide them with supplemental academic and counseling case management services as well as linkages to their school social worker while maintaining school as the students' stable environment.
