



2019-2020 School Immunization Requirements Frequently Asked Questions for Schools

1. Are immunizations required for all children enrolled in school?

Prior to entry, attendance or transfer to schools (PK-12), each child shall have on file an up-to-date Florida Certification of Immunization, DH 680 Form showing vaccinations. This will be in the form of: DH Form 680 Part A, B, or C; DH Form 680 Certification of Immunization; DH Form 681 Religious Exemption. A Temporary Medical Exemption (Part B) is invalid without an expiration date.

Please note: The DH 680 Form is not a substitute for the personal immunization card which details all administered vaccines provided to the patient/guardian.

2. Where can the parent/guardian take their children to get the required immunizations?

Parents can contact their children's physician. Another option is to visit the Florida Department of Health in Broward Immunization clinics (Edgar Mills Multipurpose Center and Paul Hughes Health Center) where vaccines for children are free of charge and no appointment needed. 3. What if I have a parent inquiring about how to get a religious exemption?

A religious exemption is issued ONLY by the local county health department. The religious exemption must be presented to the school on the Department of Health's Religious Exemption Form Immunization (DH 681 Form). No other information should be solicited from the parent or guardian. Religious exemptions do not have an expiration date.



4. Does a student have 30 days from the first day of school to turn in immunization 680 form? Can I allow/offer more time beyond 30 days for new student's immunization 680 form?

On a student's first day of school, they are to be in compliance with immunization requirements and a DH 680 or DH 681 (religious exemption) must be on file. Authorized school official issues temporary exemptions for a period not to exceed 30 days, however, these temporary exemptions are issued for the following situations:

Students transferring interstate/intrastate; A homeless child; A child who enters the juvenile justice; and Military children. Besides these qualifiers, per Broward County Public School policy and Florida Statute, students who do not have verification of immunization compliance will not be allowed to attend school.

5. Does the 680 Immunization Form have to be on blue paper?

The 680 is acceptable on white paper. A copy or facsimile of a completed and appropriately signed 680 Form is acceptable.

6. Can I get access to Fl Shots (Florida's Online Immunization Registry) to view immunization records?

7. Can a student receive the Tdap prior to 7th grade?

It is not uncommon to receive a DH 680 with a Tdap date for students 7 years old and older. Tdap is recommended for ages 11 and up however a requirement of 7th grade. Tdap is also used the catch-up series for students age 7 -10. If a student has a DH 680 form that is complete for 7th grade (Part A:Code 8), please code accordingly in TERMS even though the student may be in an earlier grade.
