Call to Order:

The School Advisory Council meeting was held at Charles W. Flanagan High school on October 18, 2021, in the Media Center. Mrs. Poitevien called the meeting to order at 4:09 P.M. Ms. Dominguez recorded the minutes for this meeting.

Minutes:

- ❖ **Principal's Update:** Mrs. Peter spoke about the Latinos in Action program and their collaboration with the feeder schools. Mrs. Peter also explained the ELO programs that are in the process of being executed in the next few weeks. For example, the after-school tutoring will be held Mondays-Thursdays from 3:00- 4:30. The parents will need to provide transportation for the students participating in the programs. The 11th and 12th grade students will have the opportunity to participate in the ACT and SAT prep in the event they do not receive a passing score on the FSA. The school's social worker will start a mental health program next month for students during study hall.
- ❖ **SAC Funding:** Currently, there is \$47,856.30 in the SAC budget. In the past, the school used these funds for programs such as USA Test Prep, Saturday camps, and other enrichment programs.
- ❖ **Department Presentation:** Mrs. Poitevien introduced herself as the ELA Support Teacher and explained the Literacy plan and the interventions for the tier 2 and tier 3 students. Mrs. Driggers's the ESE Specialist gave an update on the ESE program. Currently, 381 students are in the ESE program and 134 are in the gifted program.
- ❖ **Review of SAC Minutes:** Mrs. Ferguson motioned to approve the minutes for September 13, 2021, with one correction, Mrs. Ferguson as the I-Zone representative. Mrs. Poitevien seconded the motion for approval. The minutes are approved.
