Good day Walker families,

When we return from Spring Break, we will officially start the Florida Standards Assessment (FSA). During the month of April, all face to face students and all virtual students are expected to physically come to Walker Elementary to show what they know. For the 2021 administration, students will not be allowed to test at home.

**ON APRIL 13-14<sup>TH</sup> ALL 3RD GRADE FACE TO FACE STUDENTS WILL BE ADMINISTERED THE ENGLISH LANGUAGE ARTS (ELA) FSA. THIS READING TEST IS TWO SESSIONS OVER 2 DAYS.**

**ON APRIL 15-16<sup>TH</sup> ALL 3<sup>RD</sup> GRADE VIRTUAL STUDENTS WILL BE ADMINISTERED THE ENGLISH LANGUAGE ARTS (ELA) FSA. THIS READING TEST IS TWO SESSIONS OVER 2 DAYS.**

**ON APRIL 20<sup>TH</sup> ALL 4TH GRADE FACE TO FACE STUDENTS WILL BE ADMINISTERED THE WRITING FSA AT WALKER. THIS WRITING TEST IS ONE SESSION.**

**ON APRIL 21<sup>ST</sup> ALL 4TH GRADE VIRTUAL STUDENTS WILL BE ADMINISTERED THE WRITING FSA AT WALKER. THIS WRITING TEST IS ONE SESSION.**

**ON APRIL 27<sup>TH</sup> ALL 5TH GRADE FACE TO FACE STUDENTS WILL BE ADMINISTERED THE WRITING FSA AT WALKER. THIS WRITING TEST IS ONE SESSION.**

**ON APRIL 28<sup>TH</sup> ALL 5TH GRADE VIRTUAL STUDENTS WILL BE ADMINISTERED THE WRITING FSA AT WALKER. THIS WRITING TEST IS ONE SESSION.**

Again, all students are required to test face-to-face. If your child has been learning remotely, but typically would ride the bus, transportation can still be available. Students who have been remote that utilize bus services will be transported on their normal route and will go home at the regular dismissal time and not immediately after testing. Parents of remote students who would like to sign their children out after testing may do so. Additionally, students who have been learning remotely, will need to become wearing masks for the duration of testing. In following CDC recommendations, all students are required to have facial covering while on campus for safety. If you have any questions please feel free to call your child's teacher or the front office for more information. Testing dates for May's assessments (which include 4<sup>th</sup> and 5<sup>th</sup> grade ELA, 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> grade math, and 5<sup>th</sup> grade science) will be released shortly.
