By Monday, April 1, 2024, all public school students (District/Charter) who are out of compliance for immunization must present documentation of compliance to their school. Please complete one of the forms below.

### DH680 form - Complete one of the following sections:

#### Part A

CODE 1 - indicates the student has the required immunizations for kindergarten through 6th grade entry.

CODE 8 - indicates the student has required immunizations for 7th through 12th grade entry.

**Part B** Temporary Exemption with an unexpired date

**Part C** Medical Exemption

### DH681 form - Religious Exemption (does not expire)

\*\*\*Students who are unable to provide a current DH680 or DH681 by Monday, April 1, 2024, shall be excluded from school and/or school-sponsored activities until a DH form of compliance (DH680) or exemption (DH681) has been received.

## VOLUNTARY VACCINATIONS WITH PARENTAL CONSENT

### Providing State Mandated Vaccines to All Students in Grades K-12

#### WHO?

All public school students, including charter school students, who are missing required vaccinations.

#### WHAT?

Please bring a copy of your child's immunization record. Parent or guardian must accompany children under age 18.

#### WHY?

Vaccines keep children and communities healthy by providing safe and long-lasting protection against serious illness and complications of vaccine-preventable diseases. **It's the law!**

Pursuant to section 1003.22(1), Florida Statutes and BCPS Policy 5.5-IV.C.2, students without a completed Florida Certificate of Immunization (DH680 or DH681 form) indicating compliance with or exemption from the current schedule of required immunizations shall be excluded from school and/or school related activities. This document must be provided before entering or attending school in-person or virtually (K-12th grade).

#### HOW?

Parents/Guardians will have the opportunity to accompany their student to multiple school based vaccination events (see attached schedule). D.H. 680 forms will be provided on-site for submission to schools. Students may also visit their healthcare provider to receive vaccinations and the D.H. 680 form. Students must have a current D.H. 680 form (or D.H. 681 Religious Exemption form) on file at their school by April 1, 2024, for continued attendance. Students requiring religious exemption can get the D.H. 681 form at the Children's Reading Center & Museum, located at 751 SW 121st Ave, Davie, FL 33325.

#### I RECEIVED MY VACCINES, NOW WHAT?

##### Bring the following to your school:

Copy of DH680 (or DH 681) by April 1 to prevent being excluded from school and/or school-related activities.

Completed Emergency Contact Card providing parental consent.

#### School Immunization Requirements

**DEADLINE: APRIL 1, 2024**

#### KINDERGARTEN THROUGH TWELFTH GRADE:

- Four/five doses of diphtheria-tetanus-pertussis (DTaP) vaccine†.
- Three doses of hepatitis B (Hep B) vaccine.
- Four/five doses of polio (IPV) vaccine\*\*.
- Two doses of measles-mumps-rubella (MMR) vaccine.
- Two doses of varicella vaccine†.

#### SEVENTH GRADE:

In addition to kindergarten through twelfth grade vaccines, students entering or attending seventh grade complete the following:

- One dose of tetanus-diphtheria-pertussis (Tdap) vaccine in grades seven through twelve.
- An updated DH 680 form to include Tdap, must be obtained for submission to the school.

**Students without a completed Certificate of Immunization\* indicating compliance with the current required schedule of immunizations will be excluded from school and/or school-related activities until this document is provided. Absences due to noncompliance with immunization requirements shall be considered unexcused. (F.S. s. 1003.22(1)) (BCPS Policy 5.5-IV.C.2)**

\*Students may attend school without a DH 680 form if they have a medical exemption (DH 680-Part B/C form) or religious exemption (DH 681 form).

† The fifth dose of DTaP vaccine is not necessary if the fourth dose was administered at age 4 years or older.

\*\* If four or more doses are administered before age 4 years, an additional dose should be administered at age 4 through 6 years and at least six months after the previous dose. A fourth dose is not necessary if the third dose was administered at age 4 years or older and at least six months after the previous dose.

† Varicella vaccine is not required if Varicella disease is documented by the health care provider.
