
VAPING

The cool and dangerous new alternative to cigarettes

7 Things E-Cig/Vape Companies DON'T WANT YOU TO KNOW

- 1. E-cigs (like JUUL) contain nicotine, cancercausing chemicals, metals, and other chemicals found in regular cigarettes.
- 2. Nicotine is especially addictive for teens, and can increase anxiety levels.
- 3. 1 JUUL pod contains the same amount of nicotine as an entire pack of 20 cigarettes!
- 4. Smoking e-cigs can harm teen brain development, which continues into the early to mid-20s.
- Some e-cigs like JUUL were designed intentionally to resemble everyday items like USB drives, pens and markers.
- 6. Flavored regular cigarettes are banned because they get teens addicted. But flavored e-cigs are still on the market.
- E-cigarette aerosol is NOT harmless "water vapor."



Secondary Schools (6-12)

1st Offense:

1-2 day in-school suspension with required intervention assignments and a referral to the District Substance Abuse Case Manager

2nd Offense

6-day suspension with required intervention program assignments and a referral to the District Substance Abuse Case Manager

3rd and Subsequent Offenses:

10-day suspension, recommendation for expulsion and a referral to the District Substance Abuse Case Manager

Family Educational Rights and Privacy Act (FERPA)

FERPA

Family Educational Rights & Privacy Act of 1974



Goal: Protect Integrity of a Student's Academic Record & Protect Student's Privacy The Family Educational Rights and Privacy Act is a federal law that protects the accuracy and privacy of students' educational records. The Family Educational Rights and Privacy Act (FERPA), F.S. 1002.22, F.S. 1002.221 and SB Policy 5100.1 afford parents, guardians or eligible students (students over 18 years of age or attending a postsecondary institution) certain rights with respect to the student's education records maintained by the District. These rights are:

- The right to inspect and review a student's education records within 30 days of the day the District receives a request for access.
- The right to request the amendment of a student's education records.
- The right to consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent.
