Expedition to Excellence

1. Hollywood Hills High School and the School Board of Broward County shall not be held responsible for damage to vehicles parked or operated on school property.
2. Every student operating a vehicle on school grounds must possess a parking decal, a valid driver’s license and at least the state’s minimum insurance for the vehicle. The person registering the car at school is the only person permitted to operate vehicle on school ground.
3. Vehicles operated on school grounds must be in safe operating condition. School personnel may deem vehicles unsafe.
4. If a student’s record of behavior for the previous semester is examined and found unsatisfactory, this will be grounds to deny or revoke a Parking Permit without a refund of parking decal fees. Suspensions, and/or missed Saturday Schools will result in loss of parking privileges.
5. **Excessive Tardiness/Absences:** Unexcused Tardies to school and/or leaving school without permission, allowing your vehicle to be used by others to break school rules (sneaking students off campus) will result in suspension and revocation of the Parking Decal without a refund of parking decal fees. A student decal will be revoked for excessive tardies to school (special consideration must be discussed with your administration prior to 6th tardy). Excessive absences in a 45-day period will result in a revoked Parking Permit without a refund of parking decal fees.
6. Student parking is restricted to the designated student parking lot. Students may not park in a staff parking spot at any time. A student’s decal will be revoked without refund of parking decal fees, for parking in unauthorized areas such as: staff, handicap, other student spots, roadways, and/or double parking.
7. Student vehicles on campus are subject to search based on reasonable suspicion. Weapons, drugs, alcohol, cigarettes, lighters, and other contraband outlined by the Code of Conduct are not permitted on campus at any time. The display of offensive flags, bumper stickers, words, or other materials on a vehicle is prohibited. Violations will result in loss of decal without refund of parking decal fees and authorities may be notified.
8. Students are not permitted to remain in their cars or in the parking area after arriving on campus. Loitering in the parking lot will not be tolerated. **Students may not enter the parking area at any time during the school day without first securing permission from school security or administration.**
9. Motorcycles must be parked in the designated area. Students driving a motorcycle must wear a helmet while on campus.
10. Failure to abide by the established traffic patterns, failure to abide by the posted Speed Limit (**5 MPH**), and /or careless or unsafe operation of a vehicle (spinning tires, revving engines, etc.) will be grounds to revoke and/or deny parking privileges, without refund of parking decal fees. Students must STOP at all stop bars painted on the ground and at All Intersections on campus or their decal will be revoked.
11. Students must have original HHHS decal properly displayed in the lower driver side corner of the windshield
12. Students who change vehicles must notify the school prior to receiving a new decal. Students must bring in the new vehicle registration, insurance card, and application in order to receive a new decal. Old decals must be scraped off and turned in prior to receiving a new decal. If the old decal is not brought in, a new decal may not be available. A new decal is \$50.00, and a replacement decal (with scraped off decal) is \$10.00.
13. Failure to abide by any of the above rules will suspend your parking privilege for the remainder of the school year. Once a parking decal is revoked for breaking the above rules and or guidelines- the student may not be permitted to park on campus for the remainder of the school year.
14. Students that leave campus without permission during school hours will have their decal revoked without refund of parking decal fees and face external suspension per the Code of Student Conduct.
