## **Content Area Specialist Reports**

### Eligibility Recruitment Selection Enrollment and Attendance (ERSEA)

- The cumulative enrollment for Head Start (HS) and Early Head Start (EHS) for August 2024 was one thousand eight hundred and eighty-five (1885).
- During the month of August, Head Start continued to accept and process applications for the 2024-2025 school year.
- Families were prompted to complete a Forms Survey to request an interview.
- Once applications were processed, parents were notified of the status via email.
- Accepted families were provided with registration steps and a list of required documents needed for enrollment prior to their child attending school for the 2024-2025 school year.
- Parents completed school registration and Head Start enrollment forms online. They also uploaded the required documents into ChildPlus using their individual upload link.
- Information Management Technicians (IMTs) and other staff assisted with contacting parents to register children.
- The monthly attendance average for August 2024 was 91.30%.

### Health and Nutrition

- The Health Team continued to prepare health supplies for teachers including toothbrushes, toothpaste, band-aids, hand soap, hand sanitizer, gloves, masks, etc.
- The Health Team worked to identify medical concerns and contacted parents to discuss any dietary needs or accommodation.
- The Health Team continued to send out reminders to teachers for screening requirements, as due dates approach.

### Disabilities

- The Lead Inclusion Specialist, along with Disability Team members, reviewed all accepted children's applications and opened concerns based on parent input from their interview.
- The Lead Inclusion Specialist, along with other members of the Disabilities Team, reviewed statewide databases to ensure children who have an Individualized Education Plan (IEP) are in the appropriate classroom setting based on their individual needs.
- The Disabilities Team began developing materials to provide support to classroom teachers based on the individual needs of children.



- The Disabilities Team contacted school-based staff to schedule meetings for returning children who need to be staffed.
- The Disabilities Team met with teachers to provide support regarding classroom arrangement and interventions, and to review the Preschool Multi-Tiered Systems of Support (MTSS) process.
- The Disabilities Team participated in the Quarter 1 - Active Supervision training.

## Mental Health

- The Mental Health Team completed the Early Childhood Education (ECE) Department and District training requirements for the beginning of the school year.
- The Mental Health Team completed Quarter 1 - Active Supervision training.
- The Mental Health Team participated in the Instructional Staff Meeting with cross-discipline collaboration.
- The Mental Health Team provided Devereux Early Childhood Assessment (DECA) support/materials to all Head Start teachers on individual caseloads as necessary/requested.
- The Mental Health Team conducted individual classroom visits and provided support for active supervision.
- The Mental Health Team participated in ongoing collaboration with Parent Educators, Teacher Specialists, Behavior Specialists, Inclusion Specialists, and Administration.
- Ongoing mental health support was provided to HS/EHS children and families and behavioral and mental health referrals to community providers were created as needed.
- The Mental Health Team collaborated with community behavioral and mental health providers.
- The Mental Health Team supported HS/EHS staff and parents through email, text, phone, and virtual contacts.
- The Mental Health Team shared current/updated community resources with families and staff.
- The Mental Health Team collaborated with school-based Response to Intervention (RTI)/Collaborative Problem-Solving Team (CPST)/Multi-Tiered System of Support (MTSS) Teams.
- The Mental Health Team created referrals to Early Steps as needed.
- Individual Family Support Plans (IFSP) were uploaded into ChildPlus by the Mental Health Team when applicable.

## Parent Family and Community Engagement (PFCE)

- Parent Educators continued taking applications for the 2024-2025 school year at their school sites.
- The Family Service Specialist and Parent Educators continued to provide updated community resources to the families.
- Parent Educators continued distributing Head Start Flyers in the community and attending community events.



## Family Services

- Parent Educators continued to attend virtual meetings to support families.
- Parent Educators continued to assist parents with uploading the required application documents to ChildPlus.
- Parent Educators continued to respond to emails from families regarding pending concerns.
- The Family Service Specialist and Parent Educators continued to work together to ensure families were supported.
- The Family Service Specialist continued reaching out to outside agencies in an effort to provide additional social service support to Head Start families.

## Education

- Teacher Specialists conducted individual classroom visits and supported compliance with active supervision.
- Monthly active supervision audits were conducted by Teacher Specialists and Administration.
- Teacher Specialists completed all District and Early Childhood Education Department required trainings.
- Teacher Specialists visited classrooms and provided staff support through coaching.
- The Education Team collaborated and supported school-based RTI/CPST/MTSS Teams.
- Teacher Specialists supported classroom teachers with the Intentional Planning for Teachers 20-Day Plan, Creative Curriculum, and Teach Smart by Teaching Strategies.
- The Professional Development Team attended and monitored Quarter 1 - Active Supervision training and lab requirements.
- The Professional Development Team created Learning Across Broward (LAB) courses and sections for upcoming courses.
- The Education Team participated in instructional staff meetings.
- The Professional Development Team updated the ECE Canvas page as needed.
- The Education Team met with professional development vendors to set up links for upcoming trainings.
- The Education Team attended interviews to fill Teacher and Teacher Assistant vacancies.
- The Education Team created the Professional Development Rationale for Quarter 2-4 Active Supervision Trainings.
