









Legislative Weekly Report: Interim Committee Week 1

OVERVIEW

The Legislature held its first Interim Committee Week this week, September 16-19, 2019. The Appropriations Committee and Education Committees received presentations on the following topics: mass shootings, school safety, and the financial outlook. In terms of the Long-Range Economic Outlook, the state chief economist predicts revenue will be nearly \$1 billion less than expected in the next two years.

Additionally, the Department of Education presented the 2020 Legislative Budget Request. The Department is recommending an \$86 increase per-student in total FEFP. Majority of the increase would be allocated to the Base Student Allocation (BSA) and the Mental Health Allocation.

The Department also released their proposed reductions in educational funding, if cuts are needed. Proposed reductions would cut nearly \$1 billion from the FEFP. The BSA and other FEFP categories that fund transportation, school safety, mental health, wrap-around services, literacy, and workforce education would be held harmless (not reduced). Legislative Budget Requests (LBR) and Schedule VIIIB-2 (Reductions)

Overview of LBR:

Florida Education Finance Program (FEFP):

- -\$50/student increase in the Base Student Allocation (BSA)
- -Eliminating Declining Enrollment categorical;

Phasing-out State-Funded Discretionary categorical; and rolling these funds into the BSA

- -\$86/student increase in the total FEFP
- -\$25 million increase in the Mental Health Assistance Allocation to decrease the ratio of students to mental health counselors

Investing in Great Teachers:

- -\$284.5 million for Best and Brightest Teachers and Principals
- -\$12.8 million increase (\$37 million total) in Teacher Professional Development
- -\$10 million for Teacher Talent Pipeline new
- -\$10 million for Computer Science (CS) Certification/Bonuses
- -\$5.5 million for Youth Mental Health Training

Serving Students Unique Needs:

- -Special Needs: \$42 million increase for 4,000 Students on the Waitlist for Gardiner Scholarships
- -Literacy: \$2.4 million increase to Reading Scholarship Accounts
- -High Quality Public Charter Schools: \$40 million maintained for Schools of Hope

Office of Early Learning:

- -\$12.8 million increase for Voluntary Prekindergarten, highest BSA since 2011-2012, for a total of \$415 million
- -\$760.8 million for School Readiness Services ensures children of low-income working families receive high-quality care

Critical Technology Needs:

- -School Safety: \$8 million to fund Interoperability real-time emergency services communications in every school new
- -Student Data: \$5.5 million to modernize the DOE Mainframe and enhance DOE's support for districts, all public schools, teachers, parents and students new

Schedule VIIIB Reductions

Proposed Schedule VIII-B exercise reductions (do NOT impact - in other words, they hold harmless):

- Base Student Allocation and FEFP categories that fund transportation school safety, mental health, wrap-around services, literacy and workforce education
- Core funding for workforce education (Career & Adult);
- School Readiness & VPK
- Main Cost Cutting Considerations (in the event cuts are needed):
- Minimizing impacts to programs that provide direct services to students
- 20-30% workforce reductions across divisions
- Would necessitate consolidation strategy towards the core of the FL DOE, across divisions, with a focus on core direct services to students
- -20%-30% reductions to most recurring projects and postsecondary scholarship programs with a focus on leaving programs in good shape to rebound when an economic downturn ends -FEFP Categoricals \$945 million
