2024 Regular Session Week 3 Report

OVERVIEW

The Legislature held Week 2 of session, January 15-19, 2024, as part of the 2024 Legislative Session.

On the advocacy front, BSPS Superintendent, Dr. Peter B. Licata, and Members of the School Board School Board of Broward County, traveled to Tallahassee to participate in Broward Days, Rally to Tally, and The Florida School Boards Association Days. District staff and 42 high school students also traveled to advocate for BCPS 2024 Legislative Priorities.

The Senate Appropriations Committee on Education voted in favor of three proposed bills:

- SB 240: International Baccalaureate Teacher Bonuses
- SB 590: Music-based Supplemental Content to Accelerate Learner Engagement and Success Pilot Program
- SB 694: Florida Seal of Fine Arts Program

The Senate Committee on Education Pre-K-12 voted in favor of six proposed bills:

- SB 460: Career and Technical Education
- SB 820: Child Care and Early Learning Providers
- SB 916: School Readiness Program
- SB 1026: Early Learning
- SB 1356: School Safety
- SBPB 7038: Education

The House Education & Employment Committee observed a Presentation and Discussion on the Future of Artificial Intelligence (AI) in Education.

Senate Appropriations Committee on Education

Met on 1/17/24 at 1:30 PM

Voted Favorable:

SB 240: (Burton, CO-INTRODUCER: Perry): International Baccalaureate Teacher Bonuses

(Similar to H 667: International Baccalaureate Teacher Bonuses)

Revising the requirements for the calculation of additional full-time equivalent membership and certain bonuses based on International Baccalaureate examination scores of students to include students who earn equivalent scores as determined by the Department of Education, etc.

Summary: SB 240 authorizes the Department of Education (DOE) to determine equivalent scores for International Baccalaureate (IB) assessments which qualify for additional full-time equivalent funding and for certain school, district, and teacher bonuses based on IB exams.

BILL ANALYSIS AND FISCAL IMPACT STATEMENT

<u>SB 590 (Burgess, CO-INTRODUCER: Perry): Music-based Supplemental Content to Accelerate Learner</u> Engagement and Success Pilot Program

(Compare to H 537: Music-based Supplemental Content to Accelerate Learner Engagement and Success Pilot Program)

Creating the pilot program within the Department of Education; providing requirements for the pilot program; providing funding requirements, subject to legislative appropriation; requiring the College of Education at the University of Florida to evaluate the pilot program's effectiveness and annually share its findings with the Department of Education and the Legislature, etc.

Summary: SB 590 establishes the two-year Music-based Supplemental Content to Accelerate Learner Engagement and Success (mSCALES) Pilot Program within the Department of Education (DOE). The program is intended to assist districts in adopting music-based supplemental materials that support STEM courses for middle school students. School districts in Alachua, Marion, and Miami-Dade counties will receive \$6 per student if they are approved by the DOE and utilize the adopted music-based supplemental materials at least twice per week to supplement mathematics instruction by teachers who are certified to teach mathematics. The bill requires the College of Education at the University of Florida to continuously evaluate the program's effectiveness and annually share the findings of its evaluations with the DOE and the Legislature. The University of Florida will submit a final report by October 1, 2026, to the DOE, the Legislature, and the Florida Center for Partnerships for Arts-Integrated Teaching.

BILL ANALYSIS AND FISCAL IMPACT STATEMENT

SB 694 (Perry, CO-INTRODUCER: Rouson): Florida Seal of Fine Arts Program

(Identical to H 523: Florida Seal of Fine Arts Program)

Establishing the program within the Department of Education; providing the purpose of the program; specifying eligibility requirements for the awarding of the Seal of Fine Arts; defining the term "work of art"; requiring the Commissioner of Education and school districts to perform specified duties to administer the program, etc.

Summary: SB 694 establishes the Florida Seal of Fine Arts Program to recognize high school graduates who have met specified criteria in fine arts by having an appropriate Seal of Fine Arts (seal) affixed to the student's high school diploma. Specifically, the bill:

- Establishes the program beginning with the 2024-2025 school year.
- Sets criteria for earning the seal and permits the Department of Education (DOE) to adopt additional criteria.
- Sets requirements for the Commissioner of Education (commissioner) to prepare the seal and provide to school districts a rubric for implementation.
- Sets requirements for school districts including; maintaining records to identify students earning the seal, reporting to the commissioner, affixing the seal to the student's diploma, and indicating on the student's transcript that the seal was earned by the student.
- Prohibits fees associated with the seal.

Senate Committee on Education Pre-K -12

Voted Favorable:

<u>SB 460: (Education Pre-K -12, Simon, CO-INTRODUCER: Perry): Career and Technical Education</u>

(Similar to H 917: Career and Technical Education, Compare to H 483: Education, H 553: Career-themed Courses, S 1688: Career-themed Courses, CS/S 7000: Deregulation of Public Schools/Instructional, Administrative, and Support Personnel)

Providing an exemption for minors to work in specified conditions; providing an alternative to career fairs through other career and industry networking opportunities; revising a list of individuals who are

required to review and comment on certain revisions to the state academic standards; revising the requirements for certain credits and certifications to meet specified graduation requirements, etc. **Summary:** CS/SB 460 aims to enhance vocational and technical education. The bill authorizes minors aged 16 or 17 to work in construction if the minor:

- Has earned his or her Occupational Safety and Health Administration (OSHA) 10 certification;
- Is under the direct supervision of a person 21 years of age or older with at least two years of related experience and his or her OSHA 10 certification.
- Is not working on any scaffolding, roof, superstructure, or ladder above 6 feet.
- Is not in violation of any OSHA rule or federal law related to minors in the workplace.

The bill repeals the authority for counties and municipalities to issue journeyman licenses in the electrical and alarm system trades. The bill authorizes district school boards to satisfy the career fair requirement through consulting with specified groups to determine free or cost-effective methods to provide other career and industry networking opportunities. The bill authorizes a student who earns credit for one year of related technical instruction for a registered apprenticeship or preapprenticeship program to use such credit to satisfy high school graduation credit requirements. The bill provides an exemption from the career education basic skills assessment to certain students with a private school diploma or home education affidavit. Lastly, the bill creates the Career and Technical Education Task Force to study the status of CTE in each school district within the state.

BILL ANALYSIS AND FISCAL IMPACT STATEMENT

SB 820: (Education Pre-K -12, Grall, CO-INTRODUCER: Osgood) Child Care and Early Learning Providers

(Similar to H 635: Child Care and Early Learning Providers)

Providing an exemption for public and private preschools from specified special assessments levied by a municipality; defining the term "preschool"; authorizing the use of credits against certain taxes beginning on a specified date; providing a limitation on such credits; requiring repayment of tax credits under certain conditions and using a specified formula; revising licensing standards for all licensed child care facilities and minimum standards and training requirements for child care personnel, etc.

Summary: CS/SB 820 provides a tax exemption for preschools, various child care tax credits, modifies requirements for licensing of child care providers, and affects homeowners insurance for large family child care homes. Specifically, the bill:

- Modifies the existing exemptions from special assessments levied by municipalities to include preschools.
- Provides various tax credits for corporations and certain taxpayers who operate a child care facility or make contributions to child care facilities on behalf of employees for certain taxes including income tax, insurance premium tax, severance taxes on oil and gas production, alcoholic beverages tax, and sales tax paid by direct pay permit holders.
- Provides an exemption from licensing for certain entities operating a child care facility solely attended by its employees.
- Modifies requirements related to licensing of child care facilities by the Department of Children and Families including limitations on violations, implementation of abbreviated inspections, background screening, and personnel training.
- Removes annual notifications that child care facilities are required to provide parents regarding immunization and leaving children in cars.
- Requires county commissions to annually affirm continued services for locally managed licensing of child care facilities.
- Clarifies cancelation and coverage from residential property insurance for large family child care homes.

SB 916: (Calatayud, CO-INTRODUCER: Perry) School Readiness Program

(Identical to H 929: School Readiness Program)

Revising requirements for the sliding fee scale for families receiving school readiness program services to include a new method to calculate parent copayments at the time of eligibility determination and annually thereafter, regardless of the number of children; revising requirements for the data elements that must be collected and reported by the Department of Education; revising the method for determining the annual allocation for the school readiness program; deleting a provision relating to certain expenditures from the Gold Seal Quality Care Program allocation, etc.

Summary: SB 916 revises the School Readiness (SR) program concerning eligibility, funding and program plans. Specifically, the bill:

- Modifies the definition of "economically disadvantaged" to use state median income, rather than the federal poverty level when determining program eligibility and for reporting requirements.
- Provides a schedule for copayments for parents whose children attend the SR program based on the state median income.
- Modifies the methodology to determine the distribution of funds to early learning coalitions using the provider cost of care or reimbursement rates established by the Early Learning Programs Estimating Conference.
- Requires the principals of the Early Learning Programs Estimating Conference to provide reimbursement rates based on specified information, but removes the deadline by which official cost-of-care information must be provided to the legislature.
- Removes certain expenditure provisions related to the Gold Seal Quality Care Program, the Differential Payment Program, and the special needs differential.

SB 1026: (Education Pre-K -12, Grall, CO-INTRODUCER: Osgood) Early Learning

(Identical to H 1353: Early Learning)

Revising requirements for prekindergarten instructors; prohibiting private prekindergarten provider and public school curricula from using a coordinated screening and progress monitoring program or other specified methods for direct student instruction; revising the percentage of funds an early learning coalition may retain and expend; providing that, subject to legislative appropriation, certain Voluntary Prekindergarten Education Program students are eligible to receive instructional support in early literacy skills through a specified program, etc.

Summary: CS/SB 1026 provides programmatic and administrative changes to support the Voluntary Prekindergarten (VPK) and the School Readiness (SR) programs as well as providing additional support to struggling students entering kindergarten. Specifically the bill:

- Allows additional VPK instructors to qualify to be a lead instructor in the summer VPK program.
- Sets guardrails for use of progress monitoring and use of electronic devices in VPK classrooms and defines an "electronic device."
- Modifies specific areas related to VPK performance standards and accountability including the calculation and timing of the performance metric.
- Revises early learning standards domains to replace "self-regulation" with "executive functioning."
- Allows early learning coalitions (ELCs) to add law enforcement representation to coalition boards.
- Modifies allowable uses of School Readiness funding by ELCs.
- Creates a summer bridge program for VPK students with early literacy deficiencies prior to entering kindergarten.

SB 1356: (Calatayud) School Safety

(Compare to H 1473: School Safety)

Authorizing sheriffs to waive certain requirements for school guardian candidates under certain conditions; requiring school principals to ensure that instruction is provided at least annually to students on the use of the mobile suspicious activity reporting tool; requiring superintendents to notify, within a

specified timeframe, the chief of police or the public safety director of a postsecondary institution in which a student is dual enrolled if such student commits certain offenses, etc.

Summary: SB 1356 authorizes a sheriff to waive certain training requirements for the Chris Hixon, Coach Aaron Feis, and Coach Scott Beigel Guardian Program, if a guardian candidate has at least two years of law enforcement experience and held an active law enforcement certificate within the past 5 years. The bill also requires specific annual instruction to be provided to students regarding FortifyFL and the consequences for making:

- A threat to throw, project, place, or discharge any destructive device with intent to do bodily harm to any person or with intent to do damage to any property of any person.
- A false report, with intent to deceive, mislead, or otherwise misinform any person, concerning the placing or planting of any bomb, dynamite, other deadly explosive, or weapon of mass destruction, or concerning the use of firearms in a violent manner against a person or persons.

Lastly, the bill requires the district school superintendent to notify the postsecondary institution at which a student is dually enrolled within 24 hours of being notified by law enforcement of an alleged delinquent act by a student that would be a felony if committed by an adult.

BILL ANALYSIS AND FISCAL IMPACT STATEMENT

Last Action: Now in Criminal Justice

SBPB 7038: (Education Pre-K -12, CO-INTRODUCER: Yarborough) Education

Revising eligibility requirements for a New Worlds Scholarship Account; requiring each school district and prekindergarten provider to notify the parent of each eligible student of the process to request and receive a scholarship when providing certain screening and progress monitoring results; renaming the New Worlds Reading Initiative as the New Worlds Learning Initiative; expanding the initiative to include improvement in mathematics skills, etc.

Summary: SPB 7038 expands the focus of the New Worlds Reading Initiative to include mathematics and rebrands it as the New Worlds Learning Initiative. The bill enhances the New World Learning Initiative (NWLI) by:

- Establishing the New Worlds Tutoring Program to support school districts and schools in improving student achievement in reading and mathematics.
- Expanding the eligibility for the New Worlds Scholarship Accounts to include Voluntary Prekindergarten (VPK) students.
- Clarifying student eligibility for supports under the NWLI as identified in student progress monitoring.
- Providing a mechanism for parents to use the New Worlds Scholarship Account to make direct purchases of qualifying expenditures.





PCS for HB 929: (PreK-12 Appropriations Subcommittee, Trabulsy, CO-SPONSOR: Massullo): School Readiness Program

(Similar to SB 916: School Readiness Program)

Revises definition of term "economically disadvantaged" for purposes of school readiness program; & revises provisions relating to school readiness program.

Summary: Established in 1999, the School Readiness program provides subsidies for child care services and early childhood education for children from low-income families as defined in statute; children in protective services who are at risk of abuse, neglect, abandonment, or homelessness; foster children; and children with disabilities. The bill revises the definition of the term "economically disadvantaged" as used for the School Readiness program from having a family income that does not exceed 150 percent of the federal poverty level (FPL) to having a family income that does not exceed 55 percent of the state median income (SMI). This change will increase the number of children eligible for the School Readiness program. The bill revises requirements for the sliding fee scale for families receiving School Readiness program services to include a new method to calculate parent co-payments at the time of eligibility determination and annually thereafter, regardless of the number of children. The bill requires each early learning coalition (ELC) to use cost-of-care information collected by the Department of Education (DOE) when distributing the School Readiness program funds to eligible providers. The bill revises a data element that the DOE is required to collect and report related to ELC delivery of early learning programs to align with the bill's revised definition of "economically disadvantaged". The bill also revises the report's implementation date to July 1, 2025. The bill requires the principals of the Early Learning Programs Estimating Conference to publish official cost-ofcare information based on actual school readiness direct services program expenditures and information provided to the DOE pursuant to s. 1002.895(6), F.S., by June 1, 2024. The bill specifies that beginning in Fiscal Yea r 2024-2025 and annually thereafter, the Early Learning Programs Estimating Conference must update the cost-of-care information based on any updates to the actual school readiness direct services program expenditures and information provided to the DOE pursuant to s. 1002.895(6), F.S.

For Fiscal Year 2024-2025, the bill provides the following two appropriations and places both in reserve:
 \$75,384,882 in nonrecurring funds from the Child Care and Development Block Grant Trust Fund to the DOE for the costs associated with the change of the income eligibility requirement to 55 percent of the SMI; and

 \$100 million in nonrecurring funds from the Child Care and Development Block Grant Trust Fund for the costs associated with the implementation of provider reimbursement rates based on the costof-care information.

SUMMARY ANALYSIS

HB 1361: (Temple, CO-SPONSOR: Massullo): Education

(Similar to SB 7038: Education)

Revises provisions relating to New Worlds Scholarship Accounts, New Worlds Reading Initiative, & coordinated screening & progress monitoring system.

Summary: The bill expands the eliaibility for the New Worlds Scholarship to include students enrolled in a Voluntary Prekindergarten (VPK) Program, who exhibit substantial deficiencies in early literacy or math skills based upon the results of the most recent progress monitoring assessment. The bill requires school districts and VPK program providers to notify parents of eligible students of the process to request and receive a scholarship. In addition, the bill expands the credentials for eligible part-time tutors. The bill repeals individualized reimbursements and requires parents, of scholarship eligible students, to utilize the administrator's system to make direct purchases of qualifying program expenditures. The bill renames the "New Worlds Reading Initiative" to the "New Worlds Learning Initiative" (NWLI); expands the purpose of the initiative to include improving mathematics skills of students in prekindergarten through grade 12; and designates the University of Florida (UF) Lastinger Center for Learning as the administrator. The bill renames the "micro-credential program" to the "New Worlds micro-credential program" and expands the program to include evidence-based professional learning activities that utilize best practices for mathematics instruction. The bill creates the New Worlds Tutoring program within the NWLI, to support school districts and schools in improving student achievement in reading and mathematics and requires the program administrator to establish agreements with every school district to provide additional literacy or mathematics support to prekindergarten to grade 12 students enrolled in public school who meet certain requirements. Additionally, the bill requires the administrator to provide districts with best practice science of reading guidelines; technical assistance; professional learning recommendations; assistance in reviewing tutoring programs, professional learning programs, curriculum, and resources; and to provide an annual report summarizing district use of program funds and academic student outcomes. The bill requires the Department of Education (DOE) to provide the program administrator with progress monitoring data for eligible students within 30 days of the close of each progress monitoring period. The bill renames the "New Worlds Reading Initiative Tax Credits" to the "New Worlds Learning Initiative Tax Credits". The bill expands existing requirements to provide results from the first two administrations of the progress monitoring to a student's teacher and parents, by also requiring results be delivered to prekindergarten student instructors.

SUMMARY ANALYSIS

CS/HB 1403: (Choice & Innovation Subcommittee, Tomkow): School Choice

(Compare to SB 1444: Education, HB 7025: Education)

Repeals Hope Scholarship Program; revises contributions & provisions for Florida Tax Credit Scholarship Program; revises provisions for Family Empowerment Scholarship Program, virtual instruction program providers, private school requirements, & students in personalized education programs.

Summary: Florida's school choice programs primarily consist of the Florida Tax Credit Scholarship (FTC) including students in a personalized education program (PEP), the Family Empowerment Scholarship for students attending private school (FES-EO), and the Family Empowerment Scholarship for students with disabilities (FES-UA). The bill expands eligibility for scholarship programs to the dependent children of an active duty member of the United States Armed Forces who has received permanent change of station orders to Florida or whose home of record or state of residence, at the time of renewal, is Florida.

Additionally, the bill increases the growth rate of the FES-UA scholarship program cap from 3 percent to 5 percent, while also including an automatic increase of an additional 1 percent based on demand. The bill establishes firm deadlines for Scholarship Funding Organizations (SFO) and parents related to the application and renewal of the FTC, PEP, FES-UA, and FES-EO scholarship programs. The deadlines prioritize disbursing scholarship funds to renewal students prior to new students, and authorizes FTC funds to be used for full-time private school scholarships year-round, as long as funds remain. The bill further codifies deadlines and responsibilities of SFOs and the Department of Education (DOE) regarding the disbursement of funds for the FES scholarship program. The bill updates the quarterly reporting requirements for SFOs to include information on applications received, application review timeframes, reimbursements received, and reimbursement processing timeframes. Additionally, the bill requires a SFO to establish a process to collect input and feedback from parents, private schools, and providers before implementing substantial modifications or enhancements to the reimbursement process. The bill requires a SFO to make payment for tuition and fees for full-time enrollment within seven business days after approval by the parent and school. The bill requires the Center for Students with Unique Abilities to develop appropriate purchasing guidelines for recipients of the FES-UA scholarship. The bill also clarifies several authorized uses of scholarship funds, including, instructional materials for the FES-EO and FTC programs and transition services for the FES-UA. The bill repeals the Hope Scholarship Program, but maintains the tax credits for use by the FTC scholarship program. The bill clarifies that public school students receiving the New Worlds Scholarship remain eligible for transportation scholarships under the FES and FTC scholarship programs. The estimated fiscal impact on state government expenditures is \$106.0 million.

The House Education Quality Subcommittee observed presentations on Name, Image, and Likeness for High School Student Athletes, that included:



- Professional team contracts cannot be signed.
- Contracts must be sent to the association for review.
- The school cannot benefit financially from a student's NIL deal.
- The deal cannot have any affiliation with the school.
- The agreement should not involve any association with certain

categories including drugs, alcohol, etc.

- School representatives cannot be involved in providing the deal.
- The agreement cannot be based on an athlete's performance.

Guardrails Recommendations:

Maryland Law is strong: "Public Institutions of Higher Education – Student Athletes (Jordan McNair Safe and Fair Play Act"

1. Any contract must end upon graduation or last athletic contest of their senior year.

2. No image/ mention of their current school, mascot, logo, coaches, etc. may be used in any promotional activities

3. Nothing may happen at any school event or on school property for NIL purposes

4. No coaches/ boosters / collective may be involved in anything to do with NIL payments , setup or promotion

Suggestion Guardrails:

5. No school may advertise or mention any NIL amounts in relation to trying to get a player to attend their school

6. There should be some kind of financial education classes for players and family

7. No NIL money can be tied to a player visiting or signing with a particular college

8. No 3rd party logo or gear may be worn at any event, practice or anything tied to participating athletes

9. Club sports needs to have the same rules and enforcement



The House Education Quality Subcommittee observed presentations and Panel Discussion on the State of Early Learning in Florida, that included:

Early Learning Performance Funding Project Findings

• Child assessment scores showed teacher participation in the ELPFP demonstrated significant positive effects on children's social-emotional, physical, language, and cognitive growth and development.

• The growth rate of children was an average of 23% higher than children who did not participate; meaning children in ELPFP providers increased growth at a faster pace and made more gains in less time than their peers who did not participate in ELPFP sites.

• Program quality, as measured by teacherchild interaction scores, showed significant increases in each tier.

• The gains improved annually showing the cumulative impact of participation in the ELPFP, with scores increasing as much as 79%.

• All Tier 3 participants reported that the certified coaching they received was significantly beneficial to their teaching practice.

• 85% of Tier 2 and 3 teachers reported they collaborated with other teachers when implementing practices learned.

• 80% of teachers reported course content and strategies were extremely useful in their daily instructional practice.

• Over 80% of Tier 2 and 3 teachers reported interest in taking additional professional development and career advancement

HB 139: (Plasencia, CO-SPONSOR: Garcia): Access to High School Sports

(Identical to SB 546: Access to High School Sports)

Removes specified limitation relating to participation of certain private school students in FHSAA programs.

Summary: Continuing Florida's commitment to providing all students the opportunity to participate in interscholastic or intrascholastic sports, the bill removes the enrollment cap that previously prevented students at larger private schools, regardless of whether they offered interscholastic or intrascholastic sports, from participating in such activities at Florida High School Athletic Association (FHSAA) member public schools or member private schools. The bill maintains the prohibition on students enrolled in FHSAA member private schools from participating in sports at other FHSAA member public or private schools.

Summary: Continuing Florida's commitment to safe and fair middle and high school athletics, the bill requires that the FHSAA adopt bylaws prohibiting a student who has been sentenced as an adult for a homicide, sexual battery, or lewd or lascivious offense from participating in high school athletic

competition at its member schools. The prohibition must apply to a student regardless of the disposition of his or her case, including adjudication of guilt, withholding of adjudication, or sentencing as a youthful offender.

HB 57039: (Choice & Innovation Subcommittee and Rizo (CO-SPONSORS) Massullo): Education

(Compare to SB 994: Student Transportation Safety; CS/SB 7000: Deregulation of Public Schools/Instructional, Administrative, and Support Personnel; CS/SB 7002: Deregulation of Public Schools/School District Finance and Budgets, Facilities, and Administration and Oversight)

Revises requirements relating to district school board duties & responsibilities, requirements for student management of specified health conditions, prekindergarten instructors postsecondary educator preparation in field experiences, Florida Institute for Charter School Innovation, critical teacher shortages, collective bargaining, Teacher Apprenticeship Program, Dale Hickam Excellent Teaching Program, FCS institution employment equity accountability program, rent or lease of K-12 specified plants & facilities & sites, requirements for land for construction projects.

Summary: n 2023, the Florida Legislature passed House Bill 1 (Ch. 2023-16, L.O.F.), which included provisions regarding the deregulation of public schools. In an effort to provide more flexibility and efficiency and reduce unnecessary regulation, the bill required the State Board of Education (SBE) to develop and recommend to the Governor and Legislature for adoption during the 2024 legislative session repeals and revisions to the Florida Early Learning-20 Education Code, chapters 1000-1013, Florida Statutes. The bill provides flexibility to district school boards in satisfying their statutory duties to provide public notices related to meetings, levying millage, and the adoption of budgets by authorizing the publication of such notices to their websites rather than in a newspaper or other publication methods. The bill repeals several obsolete or overly-burdensome reporting requirements including the school district guidance report, school district report of the reduction of relocatable use, and the Florida College System employment equity accountability report. The bill supports school districts' efforts to recruit and retain teachers by requiring the SBE to develop strategies to address critical teacher shortages areas and authorizes school districts to develop and adopt their own policies relating to mentors and support for first-time teachers. The bill updates the Teacher Apprenticeship Program by expanding eligibility and clarifying that the apprenticeship lasts at least two years but may continue, if required by the apprentice and authorizes a newly-hired Voluntary Prekindergarten Education Program instructor, 30 days after hire to complete required emergent literacy training. The bill provides additional clarity for school districts and teachers unions regarding topics that may not be precluded by collective bargaining, including but not limited to, the provision of incentives to highly effective teachers, implementation of student intervention and support strategies, and the implementation of school safety plans and requirements. The bill clarifies the authority of a district school board to adopt exceptions to the State Requirements for Educational Facilities and broadens the scope of properties a district can lease or lease-purchase to include educational plants, ancillary plants, and auxiliary facilities instead of only educational facilities. The bill expands the role of the Florida Institute for Charter School Innovation at Miami Dade College (Institute) by authorizing the Institute to develop a professional learning system and design an alternative teacher preparation program to enable certified teachers at charter schools to add on coverages and endorsements to their certificates. SB 24: Victims of Reform School Abuse by Rousen

Victims of Reform School Abuse: Citing this act as the "Arthur G. Dozier School for Boys and Okeechobee School Abuse Victim Certification Act"; requiring a person seeking certification as a victim of Florida reform school abuse to apply to the Department of State by a specified date; authorizing the estate, personal representative, next of kin, or lineal descendants of a decedent who was a victim of Florida reform school abuse to submit an application on behalf of the decedent; requiring the department to review and process a completed application within a certain timeframe, etc.

Effective Date: Upon becoming a law

Governmental Oversight and Accountability; Appropriations Committee on Transportation, Tourism, and Economic Development; Fiscal Policy

SB 26: Public Records/Victims of Florida Reform School Abuse by Rousen

Public Records/Victims of Florida Reform School Abuse: Providing an exemption from public records requirements for personal identifying information included in applications submitted to the Department of State by persons seeking certification as victims of Florida reform school abuse; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc.

Effective Date: July 1, 2024

<u>SB 200: Educator Certification</u> by Gruters

Requiring the Department of Education to develop and establish a method for a person holding a professional educator certificate to place a professional certificate in inactive status while the person teaches at a nonaccredited school, etc.

<u>SB 240: International Baccalaureate Teacher Bonuses</u> by Burton

International Baccalaureate Teacher Bonuses; Revising the requirements for the calculation of additional full-time equivalent membership and certain bonuses based on International Baccalaureate examination scores of students to include students who earn equivalent scores as determined by the Department of Education, etc.

Effective Date: July 1, 2024

<u>SB 246: Conversion Charter Schools</u> by Harrell

Revising the requirements for an application for a conversion charter school; authorizing municipalities to apply for the conversion of specified public schools to charter schools; authorizing the Charter School Review Commission to solicit and review applications for conversion charter schools, etc. Effective Date: July 1, 2024

SB 294: Instructional Hours for the Voluntary Prekindergarten Education Program by Davis

Revising the instructional hours required in the Voluntary Prekindergarten Education Program to provide for an 8-hour program day in the school-year and summer programs, etc. Effective Date: July 1, 2024

<u>SB 300: Universal Free School Breakfast and Lunch Program</u> by Berman

Requiring the Department of Agriculture and Consumer Services, subject to the appropriation of funds by the Legislature, to establish and operate a program to provide universal free school breakfast and lunch meals to all public school students; deleting provisions requiring school districts to implement and charge students for a breakfast program; authorizing school districts to operate free school meal programs using offsite food preparation locations, etc. Effective Date: July 1, 2024

SB 342: School Readiness Program by Jones

Revising the definition of the term "economically disadvantaged" for purposes of the school readiness program, etc.

Effective Date: July 1, 2024

SB 344: Required Instruction in the History of African Americans by Jones

Prohibiting specified instruction and state academic standards from indicating or implying that an enslaved person benefited from slavery or the enslavement experience in any way, etc. Effective Date: July 1, 2024

<u>SB 394: School Employees</u> by Ingoglia

Citing this act as "Stratton's Law"; requiring courts that issue risk protection orders to require that the petitioner immediately notify the respondent's employer or entity of service of the issuance of a risk protection order if the respondent meets specified criteria and to notify the respondent of such notice requirement if the court issues such an order; requiring instructional personnel to disclose to their employer any prior arrests, criminal convictions, guilty pleas, pleas of nolo contendere, and any criminal records that were expunged, etc.

Effective Date: July 1, 2024

<u>SB 396: Holocaust Remembrance Day</u> by Berman

Requiring the Governor to annually proclaim a specified day as "Holocaust Remembrance Day"; requiring that "Holocaust Remembrance Day" be observed in this state's public schools and be observed by public exercise as the Governor may designate, etc. Effective Date: July 1, 2024

<u>SB 430: Florida High School Athletic Association</u> by Simon

Requiring the Florida High School Athletic Association to adopt bylaws requiring member schools to provide certain health care services to student athletes; providing minimum requirements for such bylaws, etc.

Effective Date: July 1, 2024

<u>SB 432: Cardiac and Medical Emergencies on School Grounds</u> by Simon

Citing this act as the "HeartCharged Act"; requiring each public school to have at least one automated external defibrillator on school grounds; encouraging each charter school and private school to have at least one defibrillator on school grounds and to comply with specified requirements; providing immunity from liability for school employees and students under the Good Samaritan Act and the Cardiac Arrest Survival Act; requiring the Commissioner of Education, at his or her sole discretion, to create and disseminate specified protocols and plans relating to the use of defibrillators in schools, etc. Effective Date: July 1, 2024

SB 460: Career and Technical Education by Perry

Providing an exemption for minors to work in specified conditions; revising the requirements for an annual career fair to include allowing certain employers to meet with students regarding career and technical education; revising the requirements for certain courses to receive the same rate as honors courses for purposes of student grade point averages; revising the qualifications for specified teachers of career programs, etc.

SB 530: Florida High School Athletic Association Student Eligibility Requirements by DiCeglie

Requiring the Florida High School Athletic Association to adopt bylaws prohibiting a student who is sentenced as an adult for specified offenses from participating in certain competitions, etc. Effective Date: July 1, 2024

SB 546: Access to High School Sports by Collins

Deleting a specified limitation relating to the participation of certain private school students in a specified Florida High School Athletic Association program, etc. Effective Date: July 1, 2024

Authorizing district school boards to use advanced degrees in setting salary schedules for instructional personnel, etc.

SB 748: Charter School Capital Outlay Funding by Davis
