









Legislative Update: Interim Committee Week 2 January 13-17, 2025

OVERVIEW

The Florida Legislature held its second Interim Committee Week, January 13-17, 2025, as part of the 2025 Legislative Session.

The Senate Appropriations Committee on Pre-K - 12 Education heard the presentations: Pre-K - 12 Education Budget Overview; Program Review: Individuals with Disabilities Education Act (IDEA) - Federal Funds; Program Review: Florida Diagnostic and Learning Resource Centers (FDLRS); and Program Review: University Autism Programs - Centers for Autism and Related Disabilities (CARD).

The Senate Education Pre-K - 12 heard the presentations on Supports for Families and Students with Autism: UF Center for Autism and Neurodevelopment; Center for Autism and Related Disabilities (CARD); Florida Diagnostic and Learning Resources System (FDLRS); Palm Beach School for Autism; South Florida Autism Charter School.

The House PreK-12 Budget Subcommittee held a discussion regarding the PreK-12 Budget, hearing remarks from Commissioner Manny Diaz, Jr.; Senior Chancellor Paul Burns, Division of K-12 Public Schools; Chancellor Cari Miller, Division of Early Learning; Deputy Commissioner Suzanne Pridgeon, Division of Finance & Operations; Executive Director Adam Emerson, Office of School Choice; and Vice Chancellor Darren Norris, Office of Safe Schools.

The House Education Administration Subcommittee discussed early learning system and the administration of School Readiness.

The House Student Academic Success Subcommittee held a panel discussion on implementation of CS/HB 379 -- Technology in K-12 Public Schools. In her introduction remarks, Representative Lisa Dunkley spoke highly of the Broward school system and highlighted BCPS priorities.

The next Interim Committee Week will be held January 20-24, 2025.

Special Session: Governor Ron DeSantis called for a special session of the Florida legislature to be held from January 27-31, 2025, to implement immigration policies that are anticipated from executive orders during the first week of the incoming Trump Administration. The call includes the following issues:

- combating illegal immigration
- condominium regulation
- agricultural relief in response to natural disasters
- replenishing the My Safe Florida Home program
- citizens' initiative petition process






Presentation - Individuals with Disabilities Education Act (IDEA) - Federal Funds


Dr. Peggy Yawny, Vice Chancellor of Strategic Improvement with DOE spoke about Florida's use of federal IDEA funding to support students with disabilities. Florida ranked highly on a national level with a 95% compliance score.

Florida's Federal IDEA Part B Grants



- States are awarded an allocation each new fiscal year. The majority is allocated to LEAs.
- The Office of Special Education Programs at the USED has established a formula that states must use to calculate allocations for local educational agencies.
- Each LEA completes an IDEA application annually that is reviewed and approved by the Department before funds are disbursed.
- Each LEA is monitored for eighteen IDEA indicators and Florida is monitored by USED for indicator performance and monitoring of the LEAs.






Dr. Carey Peters highlighted efforts to reduce diagnosis delays, provide interdisciplinary support, and enhance vocational training to improve outcomes for students with autism.

Center for Autism and Related Disabilities (CARD)

Dr. Anne Marie Orlando from the UF Center for Autism and Related Disorders (CARD) discussed the challenges faced by students with autism, including the increase in diagnosis rates and factors contributing to autism, primarily focusing on genetic and environmental aspects. She emphasized the need for tailored educational resources and support.

Why the Increase in ASD Diagnosis?

- Increased awareness
- Broader diagnostic criteria
- Early intervention findings may prompt referral for to pediatricians for evaluation of ASD
- Better ASD awareness training for pediatricians
- More informed parents
- Diagnosis can lead to more services



Palm Beach School for Autism

Anne Eisenberg and Allison Allen showcased their school's achievements in providing specialized education and supporting students' transition to adult life. Challenges include teacher recruitment and navigating changes in Medicaid support.

South Florida Autism Charter School

Glenn Pierce called for increased support for specialized charter schools, noting that operational funding in Florida is robust but startup resources are lacking. He emphasized the need for comprehensive services and proposed converting underutilized district assets into housing and vocational centers for adults with autism.



Education - A Need for ASD Charter Schools





Highlights:

- **Diagnosis Delays**: There is a significant delay (average 181 days) between initial referral and diagnosis, primarily due to a shortage of trained professionals.
- **School Models**: Charter schools like Palm Beach School for Autism and South Florida Autism Charter School have demonstrated successful models for autism education using operational funding. However, challenges remain in initial funding and recruitment of audified staff.
- **Family and Community Support**: Autism affects entire families, necessitating comprehensive resources and community involvement. Schools are urged to provide robust family support and public awareness programs.

Action Items:

- **Expand Autism Charter Schools**: Encourage the establishment of more autism-specific charter schools to meet growing demand, focusing on initial funding and leveraging existing district facilities.
- Improve Diagnostic Capacity: Address shortages in diagnostic professionals through training and support, particularly in rural areas.
- **Support Transition to Adulthood**: Enhance programs that facilitate the transition from school to work for students with autism, and explore innovative housing solutions for autistic adults.




Highlights:

- **Teacher Salaries**: Discussions on teacher salary highlighted past investments and potential future increases.





The meeting focused on the challenges and initiatives related to education in Florida, discussing conflict resolution training in schools, early learning readiness, vocational education, and technology in education. Legislators addressed socioeconomic disparities, and shared insights on regional issues and innovative programs aimed at improving student outcomes.

Highlights:

- Conflict Resolution in Schools: Legislators emphasized the need for conflict resolution and deescalation training for students, comparing it to past DARE programs aimed at drug education. A bill has been filed to promote this initiative.
- Early Learning and Grade Preparedness: Legislators highlighted the importance of early learning, advocating for extended VPK programs to prepare students from economically disadvantaged communities for school.
 - School Year Program: 540 hours between August and June.
 - Summer Program: 300 hours between May and August.
 - Specialized Instructional Services (SIS): Program for children with individual educational plans
 (IEP) who need additional support outside of a traditional VPK setting.

VPK Provider Participation FY 23-24







- Career and Technical Education: Several speakers stressed the value of vocational education and the need for apprenticeship and dual enrollment programs.
- **Technology in Education**: Legislators discussed the role of AI and virtual reality in education, emphasizing the need for Florida to lead rather than follow in tech advancements.
- **Teacher Recruitment and Retention**: The panel recognized the critical shortage of qualified teachers, suggesting improvements in pay, professional development, and incentives to retain educators.

Regional Insights:

- Miami Dade's diverse socioeconomic landscape was discussed, with issues ranging from technological education to addressing the challenges faced by immigrant students.
- The rural challenges of Monroe County were highlighted, touching on teacher shortages and the need for vocational education.

Action Items:

- **Explore Conflict Resolution Programs**: Implement programs similar to DARE for conflict mediation in schools.
- **Enhance Early Learning Access**: Consider policies to support VPK extensions and dual enrollment for adult learners in technical fields.
- **Increase Teacher Support**: Invest in programs like TEACH to support teacher education and retention.
- **Utilize Technology**: Leverage AI and other technologies to enhance educational outcomes and engagement.
- Address Socioeconomic Disparities: Review real-time tracking systems for student enrollment to aid in resource allocation.
- **Future meetings**: The next topics of discussion will focus on K-12 attendance and school safety, featuring superintendents from both urban and rural areas to provide a comprehensive understanding of these issues across different communities.

The meeting focused on discussing the implementation and effects of **CS/HB 379 -- Technology in K-12 Public Schools** aimed at enhancing student academic success by limiting cell phone usage in schools. The bill's goals include reducing distractions and educating students on social media literacy.

Highlights:

- **CS/HB 379**: Representative Yeager introduced the bill in 2023 to reduce classroom distractions by removing cell phones and educating students on social media risks.
- **Bill Implementation**: Different districts adopted varied approaches. Orange County implemented a strict 'bell to bell' no phone policy, while Pasco County allowed some flexibility.
- **Social Media Literacy**: Discussions involved incorporating lessons on social media danger into the curriculum to help students and parents understand the impact.
- **Mixed Feedback**: There was array of comments; some teachers have found it helpful, while others may not have fully implemented the policy.
- **Parental Concerns**: Concerns about communication during emergencies were addressed by allowing access to phones for emergencies, with clear policies in place.
- **Student and Teacher Engagement**: Positive feedback was reported due to enhanced student interaction and students focusing during class.

Action Items:

- **Data and Feedback**: Continued monitoring of the policy's effects on behavior and academic performance.
- Improving Social Media Literacy: Need for more comprehensive DOE-provided resources for teaching students about social media's impact.
- The committee planned to continue assessing the implementation of the bill and encourage feedback from districts to refine policies further.

SB 52: School Buses by Garcia

Revising the definition of the term "school bus" as it relates to state uniform traffic control; revising the definition of the term "school bus" as it relates to driver licenses to include a motor vehicle used to transport students to and from a charter school, in addition to a public or private school, etc.

SB 70: Instructional Hours for the Voluntary Prekindergarten Education Program by Berman

Revising the instructional hours required to be delivered in the Voluntary Prekindergarten Education Program for school-year and summer programs, etc.

SB 72: Use of Campaign Funds for Child Care Expenses by Berman

Authorizing a candidate to use funds on deposit in his or her campaign account to pay for child care expenses under specified conditions; requiring candidates to maintain specified records for a specified timeframe and provide such records to the Division of Elections, etc.

SB 74: Universal Free School Breakfast and Lunch Program by Berman

Requiring the Department of Agriculture and Consumer Services, subject to the appropriation of funds by the Legislature, to establish and operate a program to provide universal free school breakfast and lunch meals to all public school students; deleting provisions requiring school districts to implement and charge students for a breakfast program; deleting provisions requiring only certain school districts to implement a universal free school breakfast program and encouraging districts to provide free breakfast meals; authorizing school districts to operate free school meal programs using offsite food preparation locations, etc.

SB 76: Paid Parental Leave by Berman

Defining the term "paid parental leave"; requiring the state to provide paid parental leave to certain employees for a specified period of time; prohibiting the state from refusing to grant such leave, etc.

SB 100: Display of Flags by Governmental Entities by Fine

Defining the term "governmental entity"; prohibiting governmental entities from erecting or displaying certain flags; requiring governmental entities to remain neutral in certain circumstances; authorizing a current or retired member of the United States Armed Forces or the National Guard to use reasonable force to prevent the desecration, destruction, or removal of the United States flag or to replace such flag to a position of prominence, etc.

SB 102: Exceptional Student Education by Gaetz

Requiring the Department of Education to develop and implement, by a specified date, a workforce credential program for students with an autism spectrum disorder; requiring the department to produce an annual report during a specified timeframe, etc.
