# Old Business -

### 2. STATUS - Student Information System – Focus

- ii. Case management the ESE team and IT was working towards understanding how to build the system to do the processes that are currently being built. IT and the entire ESE division are working on documenting what there is in the program and working with the ESE team to identify what changes need to be made.
- iii. Recommend to have Stephanie Acosta attend our next meeting to provide clarity as to what the department is doing along with the data intelligence team.
- iv. Each meeting will have a report updating the status of SIS and SSS.

- 3. **STATUS** <u>Maximo System review</u> three areas of enhancements are needed.
  - i. Utilizing PPO worker on developing forms.
  - ii. Looking at utilizing dollars to go to an ITB to find someone to help us maximize Maximo and/or work with IBM as we still have residuals left with them.
  - iii. Hand devices would be deployed to staff.

#### 6. STATUS: Audio Visual Enhancement Project at Deaf and Hard of Hearing Schools

• the Deaf and Hard of Hearing (DHH) Audio Visual Enhancement Project that includes the installation of a new system at four schools with DHH special programs: Peters Elementary School, Tropical Elementary School, Seminole Middle School and South Plantation High School. Discussion was about the type of wiring and conduit needed to complete the project. The

Building Dept is determining whether it is a life safety and determines the fire rating of the conduit. A letter was sent to the parents of those schools. See attachment B with an outline the timeframe for completion.

7. State e-Rate funding: Effect on IT Budget – Last year the focus was upgrading wireless at 30 schools. This year the department is doing wireless at 10 schools, mostly at the high schools that haven't been updated in 10 years.

# **New Business**

#### 1. Here Comes the Bus

i. Software program was updated. While permanent bus route changes are handled in school bus route planning software, temporary, on-demand changes can be made in in the K-12 fleet management solution software. More than a school bus GPS tracking system, the solution integrates with school bus route planning software, reading information about stop locations and riders. Using the bus substitution feature, dispatchers can easily assign one bus's run to another bus. With the stop-level substitution feature, parents will be able to track the location of the substituted bus as it nears their child's stop to better time pickups and drop-offs

2. <u>Xello</u> replaces Naviance. The district has Naviance until September 29, 2023. The official launch of Xello is October 1<sup>st</sup>. The integration with Clever is taking place. The department is providing principles with a pivot memo that includes documents to help them see the student facing side, the staff facing side, along with guidance counselors, school counselors, IMT's and school registrars. They will be trained on it this month. Student data will be transferred, but any sort assessments that students may have taken, resumes that have been completed or any groups that have been created would not transfer over.

Welcome to the 2023/24 school year! The Safety, Security, and Emergency Preparedness Division (SSEP) and the Information Technology Division (IT) would like to provide a joint update regarding the DHH Audio and Visual Enhancements Project for Peters Elementary School, Tropical Elementary School, Seminole Middle School, and South Plantation High School. This project includes the installation of hardware that will enhance safety for DHH students and staff through visual emergency alerts.

Initially, we had an estimated project completion date of July 2023. Unfortunately, we faced some setbacks, so the new timeline has been adjusted to account for this and other project challenges, and the new timeline should be completed by November 2023.
