Dr. Hepburn and staff have initiated the pathway to ensure the plan for engaging District stakeholders and community partners in developing a comprehensive process and plan to redefine our schools that is Community-supported, District-led, and Board-approved. A current review of all magnet and innovative programs is underway. The District's complete portfolio of schools is being analyzed through the context and criteria the School Board approved at the June 18, 2024, Regular School Board Meeting. Staff attended the July 10, 2024, Oversight Committee Public Meeting at the Government Center West to provide an update on Redefining Our Schools and respond to inquiries from the committee members. As staff narrows the list of schools to be addressed, conversations with identified communities will take place. A Redefining Our Schools item will be placed on the August 27, 2024, School Board Workshop Agenda.
