SUBJECT: **SUPERINTENDENT'S 2020/21 SCHOOL ATTENDANCE AREAS,
BOUNDARIES AND SCHOOL USAGE RECOMMENDATIONS**

Based upon staff's review of boundary considerations, community input, and School Board discussion at the January 28, 2020 School Board Workshop, it is my recommendation that there will be no changes except to add an Entrepreneurial Leadership Military Academy at Boyd Anderson High School to begin in the 2020/21 school year. All other school attendance areas and school usage will remain the same in the 2020/21 school year as they are in the 2019/20 school year, or follow previously adopted grade phase-ins.

The four proposed K8 models: Mary M. Bethune Elementary and Attucks Middle, Driftwood Elementary and Driftwood Middle, Broward Estates Elementary and Parkway Middle, and Hollywood Central Elementary as a K8 configuration will not move forward for the 2020/21 school year.

As there are no recommended changes, public meetings to discuss the 2020/21 school attendance areas and school usage for all elementary, middle, high and combination schools will be held **during regularly scheduled School Board Meetings on March 3, 2020 and March 18, 2020, at a time certain 5:30 PM start time in the Kathleen C. Wright School Board Room.**

ASUNTO: LAS RECOMENDACIONES DEL SUPERINTENDENTE SOBRE LAS ZONAS DE ASISTENCIA ESCOLAR, LOS LÍMITES Y EL USO DE LAS ESCUELAS

Sobre la base de la revisión de los límites por el personal, el aporte de la comunidad y la discusión de la Junta Escolar en el *School Board Workshop*, el 28 de enero de 2020, mi recomendación es que no se realicen cambios, a excepción de la implementación de la Academia Militar de Emprendimiento y Liderazgo (Entrepreneur and Leadership Military Academy) en la escuela secundaria Boyd Anderson a comienzos del año escolar 2020/21. Todas las otras zonas de asistencia y el uso de las escuelas continuarán igual durante el 2020-21 así como en el año escolar 2019/20, o seguirán con las medidas aprobadas previamente.

Los cuatro modelos K8 que no continuarán siendo recomendados para el año escolar 2020/21 son: Mary M. Bethune Elementary y Attucks Middle; Driftwood Elementary y Driftwood Middle; Broward Estates Elementary y Parkway Middle; y Hollywood Central Elementary.

Debido a que no se han recomendado cambios, se llevarán a cabo reuniones públicas para discutir las zonas de asistencia y el uso de todas las escuelas primarias, intermedias, secundarias y combinadas para el 2020/21 **durante las reuniones regulares de la Junta Escolar, el 3 de marzo y el 18 de marzo de 2020, a las 5:30 p.m. en el Board Room de Kathleen C. Wright.**

ASSUNTO: ZONAS ESCOLARES, DEMARCAÇÕES E RECOMENDAÇÕES DE USO ESCOLAR DO SUPERINTENDENTE PARA 2020/21

Com base na análise de demarcações de zonas escolares por nossa equipe, nas opiniões da comunidade e na discussão do Conselho Escolar na reunião do Conselho de 28 de janeiro de 2020, minha recomendação é que não haja mudanças, exceto pela adição de uma Academia Militar de Liderança Empresarial na Boyd Anderson High School a iniciar no ano letivo de 2020/21. Todas as outras zonas escolares e uso de escolas permanecerão os mesmos no ano letivo de 2020/21, tal como são agora no ano letivo de 2019/20, ou seguirão a introdução gradual de séries adotada anteriormente.

Nenhum dos quatro modelos propostos de K8 seguirão adiante no ano letivo de 2020/21: Mary M. Bethune Elementary e Attucks Middle, Driftwood Elementary e Driftwood Middle, Broward Estates Elementary e Parkway Middle, e a configuração proposta de K8 da Hollywood Central Elementary.

Como não há recomendações de mudanças, as reuniões públicas para abordar as zonas escolares e uso de escolas de 2020/21 de todas as escolas de ensino fundamental, intermediário, médio e escolas combinadas serão realizadas **durante as reuniões regulares do Conselho Escolar em 3 de março de 2020 e 18 de março de 2020, às 17h30, na sala do Conselho Escolar do edifício Kathleen C. Wright.**
