What is my child's assigned school?

Every child in Broward County is assigned a District school based on his or her home address. To identify your child's assigned school, visit browardschools.com/school-locator.

Can my child attend any school in Broward County?

By state law, students may apply to attend any public school in Florida that has not reached capacity, regardless of their home address. To determine which schools have available seats, District staff reviews expected student enrollment and space at all District schools.

Parents may apply online for a school that has available seats by completing a School Choice application during an open application window.

School Choice applications are awarded using a computerized random selection process. If more seats at a school become available during the School Choice process, additional selections from the applicant pool are made. To view waitpool selection dates, visit *Notification Dates* on browardschools.com/schoolchoice.

There is no guarantee your child's School Choice application will be granted; however, your child may always attend his or her assigned school. **All school-aged children must attend school regularly per state law.**

Important Dates

December 1, 2018 - February 6, 2019
School Choice Phase I application window.

March 13, 2019
Applicants are selected and notified.

Additional application windows for remaining available seats.

May 1 – May 8, 2019
Second opportunity to apply for a School Choice option. Note: If you already applied for the desired school, there is no need to reapply.

June 5, 2019
Additional applicants selected and notified. All applicants not previously selected will be considered.

July 1 – July 8, 2019
Third opportunity to apply for a School Choice option. Note: If you have already applied for the desired school, there is no need to reapply.

August 5, 2019
Additional applicants selected and notified. All applicants not previously selected will be considered.

August 7 – August 27, 2019
Final opportunity to apply for a School Choice option. Note: If you already applied for the desired school, there is no need to reapply. *Applicants selected and notified within three business days of applying.*
