

## **Proposal C-12**

Proposal submitted by <u>Guy Maman</u> to relieve overcrowding at Marjory Stoneman Douglas High School for the 2023/24 school year and beyond.

Phase-in Area "A" from Marjory Stoneman Douglas High School to Coral Glades High School, and phase-in Area "B" from Marjory Stoneman Douglas High School to Coral Springs High School, so that students who reside in the impacted area and attend Marjory Stoneman Douglas High School in the 2022/23 school year will continue to be assigned to that school through their 12th grade year, and any high school students residing in the proposed boundary change area but not attending Marjory Stoneman Douglas High School in the 2022/23 school year will be assigned to Coral Glades High School (Area "A") or Coral Springs High School (Area "B") beginning in the 2023/24 school year.

Schools Involved	Marjory Stoneman Douglas High, Coral Glades High, Coral Springs High					
Description	Phase-in the portion of the Marjory Stoneman Douglas High boundary south of Wiles Road and west of Coral Hills Drive/ Northwest 29th Street/ Northwest 99th Avenue (TAZ 107, 112, 653) to Coral Glades High. Phase-in the portion of the Marjory Stoneman Douglas High boundary south of Wiles Road and east of Coral Hills Drive/ Northwest 29th Street/ Northwest 99th Avenue (TAZ 107, 112, 653) to Coral Springs High.					
Class Size Impact	No adverse impact.					
Level of Service Impact	Is projected to enable Marjory Stoneman Douglas High to meet the LOS target by the end of the phase-in.					
Enrollment Impact	No adverse impact: moves 233 students from Marjory Stoneman Douglas High to Coral Glades High and 118 students from Marjory Stoneman Douglas High to Coral Springs High, for a total of 351 students. Coral Glades High will have sufficient space if future reassignment awards are reduced.					
Diversity Impact	Does not change the overall percentage of population of any demographic subgroup beyond +/-5% within the total school population of Marjor Stoneman Douglas High or Coral Glades High.					

Feeder Pattern Impact	Splits the elementary to high school feeder pattern Country Hills Elementary currently feeds 100% to Coral Springs Middle and then to Marjory Stoneman Douglas High; proposal would feed to Marjory Stoneman Douglas High, Coral Glades High, and Coral Springs High. Also further splits the middle to high school feeder pattern: Coral Springs Middle currently feeds to both Coral Glades High and Marjory Stoneman Douglas High proposal would add Coral Springs High as a third school in the feeder pattern.					
School Proximity Impact	Reduces travel distance for students in TAZ's 112 and 653. 55 students who live in TAZ 107 in the Marjory Stoneman Douglas High two-mile walk boundary would travel further to attend Coral Glades High or Coral Springs High. All students who live in TAZ 107 would travel further to attend Coral Glades High or to Coral Springs High.  CONSIDERATION RE-WRITTEN 10/25/2022
