

This memorandum provides the official school district enrollment to be used for statistical purposes. Recall that this data was secured on September 13, 2006, Preliminary 2006-07 Twentieth Day Enrollment Report. As can be seen in the majority of attachments and in Appendices A, B, C, and H, the total enrollment for this year on the twentieth day was 262,616 representing PreKindergarten (PreK) through grade 12 students enrolled in all schools, centers, and charters.

As shown in Table 1, each year between 1997-98 and 2004-05, annual enrollment districtwide was on the increase ranging from a one-year gain of 10,969 in 2001-02 to 1,352 in 2004-05. This year, the District decreased in enrollment for the second year in the past ten years by 8,319. When comparing the difference in student numbers from 1997-98 to 2006-07, enrollment grew from 223,633 to 262,616, representing an overall increase of 38,983 from ten years ago. In Appendix A, current year enrollment compared to 2005-06 demonstrated a growth at the centers by 779 students and at the charters by 964 students. PreK, elementary, middle, and high school levels all experienced decreases in enrollment this year when compared with last year.

The District is divided into four geographic administrative areas. When analyzing enrollment patterns by area for the 2006-07 year, Table 2 below demonstrates that the numbers of PreK through grade 12 students vary among areas. North Central has the lowest student enrollment of 56,736 that includes 16,100 in charter schools and 3,067 in centers. The remaining three areas serve between approximately 61,000 and 75,000 students: North, 68,563; South Central, 61,803; and South, 74,902.

As shown in Table 3 below, the South Area continues to enroll the largest number of students at 74,902. The North Area evidenced the largest decrease from last year to this September, decreasing 3,257 students. The North Central, South Central, and South Areas all experienced decreases as well.

As is noted in Appendix G, the North Central Area Office supports 13 center-related programs that serve the highest number of center enrolled students at 3,067 when compared to the other three areas (North, 330; South Central, 89; and South, 617). Within the District there are five centers with programs that serve PreK students in addition to those enrolled in Kindergarten through grade 12: Hallandale Adult, 57; Dave Thomas Education Center, 150; Seagull Center, 245; The Quest Center, 82; and Whispering Pines, 30 for a total of 564 PreK students.

Detailed information regarding enrollment of PreK students in our schools and centers is included in Appendix D. The programs range from Voluntary PreK, Head Start, PLACE/PEPPER/SALT/SPICE to Other.

Appendix E reports that based on our Twentieth Day Membership Count, 21 elementary, 7 middle, and 4 high schools have been identified this year as critically overcrowded. Recall that calculations for critically overcrowding status are based on a comparison of permanent capacity as determined by the Florida Inventory of School Houses (FISH) and student enrollment.

Table 4 illustrates diversity breakdown districtwide for the last two school years. Appendix F provides breakdown by school, center, and charter.

As shown in Table 4 and as listed by school in Appendix F, the percentage of males and females remained relatively constant over the last two years. Black students comprise the highest number and proportion of students in Broward, 97,698 and 37.2 percent respectively, with a one-year decrease of 2,374 students noted when comparing 2005-06 and 2006-07 data. White student enrollment decreased in number and proportion when compared to 2005-06 at 82,676 and 31.5 percent, respectively. The Multiracial student population experienced the only increase, up 244 students compared to last year. Hispanic, Asian, and Native American student populations all decrease of 776 students while ESE experienced a slight decrease of 792. Free/Reduced Lunch (FRL) had a decrease of 4,636 students.

Appendix G provides school enrollment disaggregated by grade levels of PreK through grade 12. In addition, enrollment versus 2006-07 projections is provided as well as permanent capacity. The 2006-07 enrollment projections were about 2.3 percent above the twentieth day count while total permanent capacity evidenced a need for just over 6,000 student seats to meet current enrollment demands.
