SUBJECT: **PRELIMINARY 2010-11 TWENTIETH DAY ENROLLMENT REPORT**

This memorandum provides the preliminary school District enrollment to be used for statistical purposes. Total enrollment for this year on the twentieth day is 256,872 representing prekindergarten (PreK) through twelfth grade students enrolled in all District elementary, middle and high schools, centers, and charter schools. The final Twentieth Day Enrollment Report, to be distributed on September 23, 2010, will include individual school enrollment data disaggregated by gender, race, ethnicity, English Language Learners (ELL), Exceptional Student Education (ESE), Free or Reduced Lunch (FRL) and the ten year enrollment trend.

The Districtwide enrollment including centers and charter schools **increased this year by 1,669 students compared to the 2009-10 twentieth day enrollment.** The table below shows the historical twentieth day enrollment count change over the past five years.
