SUBJECT: PRELIMINARY 2017/18 BENCHMARK DAY ENROLLMENT REPORT

Beginning in the 2013/14 school year, the District's benchmark enrollment reporting date was moved from the twentieth day of school to the Monday following the Labor Day holiday. However, due to the impacts of Hurricane Irma, which forced schools and district offices to close on September 7, 2017 and not reopen until September 18, 2017, an official enrollment date for statistical purposes for Broward County Public Schools needed to be selected. In order to allow students whose families may have evacuated South Florida in advance of the storm to return to school, as well as to capture any increase in enrollment due to displaced students from other counties, it was determined that the date would need to be extended. Monday, September 25, 2017 was selected as the date that allowed for the most accurate enrollment count, while reducing potential impact to the Boundary Process and Demographics & Student Assignments Department timelines for events and the release of critical statistical reports.

The District's total enrollment to be used for statistical purposes reported on Monday, September 25, 2017, was **271,517**, representing prekindergarten (PreK) through twelfth grade students enrolled in all District elementary, middle, high, combination, center, and charter schools. The final comprehensive Benchmark Day Enrollment Report, to be released on September 28, 2017, will additionally include individual school enrollment data disaggregated by gender, race, ethnicity, English Language Learners (ELL), Exceptional Student Education (ESE), and Free or Reduced Lunch (FRL).

Enrollment in District schools, including centers but not charter schools, increased this year by 684 students compared to the 2016/17 benchmark day enrollment. Enrollment at charter schools decreased by 412 272 students. The table below shows the historical benchmark day enrollment count change over the past five years.

This appendix also provides the difference between the actual and projected enrollment in addition to the number of students over or under each school's Florida Inventory of School Houses (FISH) permanent capacity. Also attached is a revised Boundary Process Timeline that accounts for the later enrollment reporting date and the disruption to the lives of students and families. The new timeline will be communicated and shared through the District Advisory Council, municipal officials, directors and principals, and the District's Public Information Office communication tools.
