

NOMINEE'S ELIGIBILITY FOR SERVICE
ON SCHOOL BOARD ADVISORY COMMITTEE
(Revised March 19, 2019)

School Board Advisory Committee Members are governed by portions of the Florida Code of Ethics for Public Officers and Employees including, without limitation, Section 112.313(3) and (7), Florida Statutes. Section 112.313(3) and (7), Florida Statutes, **ordinarily prohibits** a person from serving on a School Board advisory committee from the actions described on this form.

However, Section 112.313(12), Florida Statutes, allows The School Board of Broward County, Florida ("The School Board") to waive the requirements of Section 112.313(3) and (7), Florida Statutes, to enable a person to serve on an advisory board upon a full disclosure of the transaction or relationship to The School Board prior to the waiver and an affirmative vote in favor of the waiver by a two-thirds (2/3) vote by The School Board.
