It is 10:48 a.m. on Thursday, August 13th of 2020, and we are now ready to begin the meeting of the nominating committee of the audit committee of the School Board of Broward County, Florida.

If I can kindly ask the attendees to the meeting to please place themselves on mute, we will also try to do that, as well, for you; and then when it's time to speak, if you can kindly speak.

My name is Joris Jabouin. I am the chief auditor for the School Board of Broward County. I will serve as chair pro tem for this meeting.

We will now start the meeting by standing up for the pledge of allegiance.

(Whereupon the pledge of allegiance was recited.)

MR. JABOUIN: Okay. Thank you very much.

We will now begin the process to consider the candidates for the chair and vice chair of the audit committee. If the members of the nominating

DR. LYNCH-WALSH: Here.

MR. JABOUIN: Mr. Robert Mayersohn?

Mr. Andrew Medvin?

Ms. Stephanie Shimm?

Thank you. I am hoping that someone from my team has been able to make contact with Ms. Connie Pou; but at this time, I'd like to -- as we try to connect with Ms. Pou, I'd like to make reference to Article Three, Section Three, of the audit committee bylaws, and that states that the audit committee shall annually elect a chair and vice chair and neither of those offices may be held by a member for more than two consecutive years. After serving as chair for two years, a member may not serve as an officer of the audit committee for a period of at least two years.

Also, please make reference to Article Four of the audit committee bylaws with respect to officers. Section One states that officers of the audit committee shall consist of the chair and vice chair and any other deemed necessary by members of the committee for the function of the committee. The officers shall be elected annually at the first meeting of the school year. Installation of new

officers will be held at the first meeting of the school year.

With respect to the nominating committee, that's in Section Five of Article Four, it says that it is to be determined by the audit committee and that the nominating committee will present a slate of candidates for each office, at which time nominations from the floor will be taken.

The former -- the now former chair, Mr. Moses Barnes, completed his second term as chair at the committee last meeting on June 18th. He is the only member that is restricted in a way that he cannot be considered for chair or vice chair. All other members may be considered as either chair or vice chair.

I would like to ask whether or not, Ms. Pou, are able to hear me? And I'm hoping that my team has tried to make contact with Ms. Pou. Let me quickly check the -- I do see that there is a comment there that my team is working with Ms. Pou. She is connected, but we cannot hear her.

I would like to ask, if she can dial in to the meeting, that will allow us to use the audio from her phone.

Ms. Pou, if can you hear us, the number is

MR. VIGNOLA: You might repeat that so she has a chance to get a pen and paper handy.

MR. JABOUIN: Thank you very much.

The number again, very slowly, is area code (754)216-1864, and then the conference ID is 483639176, one moment, and that number, Ms. Pou, was just posted in the chat.

Okay. We do have some -- an update in the chat. We will give a moment, as Ms. Pou will dial in very soon.

MS. POU: Hello?

MR. JABOUIN: Good morning, Ms. Pou.

MS. POU: Good morning. I'm sorry I haven't been able -- I could see you, but I couldn't hear you. I don't know why.

MR. JABOUIN: Thank you, Ms. Pou. We are glad to have you here. Now you can both see and hear us for the meeting; that's great. Okay. So thank you, Ms. Pou.

I was just mentioning, just to pick it up there, that the former chair, Mr. Moses Barnes, he completed his second term at the committee's last meeting on June 18th of 2020, and he is the only member who is restricted in a way that he cannot be

considered for chair or vice chair, but all other members may be considered as either chair or vice chair.

So, at this particular point, the audit committee, at their May 14th, 2020, meeting, the following members were appointed to the nominating committee, and that's Mr. Robert De Meo, Ms. Connie Pou, and Ms. Phyllis Shaw.

So at this time, I would like to ask the nominating committee to please select a chair amongst themselves that will report to the full audit committee following this meeting, and I would like the nominating committee to discuss and elect a nominee that would serve as chair of the audit committee.

And I would also like to ask the members to -of the nominating committee to discuss and elect a
vice chair that would serve the audit committee.

If I can please ask for that to begin now.

MS. POU: So, are you going to do a roll call, or how are you going to do this?

MR. JABOUIN: Yes, so, Ms. Shaw -- we did do the roll call, and Mr. De Meo is on the line, and so is Ms. Shaw and yourself.

MS. POU: No, I mean, are you going to ask for

each individual member to -- how are we going to select our chair and vice chair?

MR. JABOUIN: I --

MS. SHAW: It's a discussion amongst us.

MR. JABOUIN: Thank you.

Yeah, amongst you. I can give you the names of the members so you can have that discussion.

MS. POU: Well, I have Mr. De Meo, Ms. Shaw, and myself.

MR. JABOUIN: Yes, for the nominee; and the people that are available for you to consider are the members of the audit committee, which are Ms. Rebecca Dahl is eligible, Ms. Hagen Disch, Ms. Mary Fertig, Mr. Michael Gauci, Dr. Nathalie Lynch-Walsh, Mr. Robert Mayersohn, Mr. Andrew Medvin and Ms. Stephanie Shimm are all eligible to be considered by the committee as they discuss amongst themselves.

MS. POU: Okay. Thank you.

MS. SHAW: This is Phyllis. I would like to recommend to the audit committee Robert Mayersohn as the chair. He has been a vice chair, and I think it's a good natural order if he is entrusted.

MS. POU: I -- Connie Pou, I agree with that recommendation. I think he is probably -- since he

has been there, and as vice chair, I think he would do a very good job as a chair.

MR. DE MEO: And I agree with you. I think Robert Mayersohn would be my selection for chair.

I would also recommend Mr. Andrew Medvin as vice chair. He has held that position before, and he is very familiar with the audit committee's workings.

MS. SHAW: I have no objection to that --

MS. POU: I agree with that.

MS. SHAW: -- selection.
