The RISE Program located at Pine Ridge Education assists students entering 5th Grade who have been retained for two or more grade levels. The students who complete the program would transition to 7th Grade. He stated January is National Mentoring Month; and mentioned Think Before You Post training to students.

CHAIR'S REPORT

Ms. Pierre-Grant attended the Long-Range Facilities meeting. Topics included in the meeting were playgrounds, work orders.

MOTION
