Improper drying, wet nesting of equipment (pans) after sanitization. Corrected onsite - equipment brought to 3-compartment sink to be washed, rinsed, sanitized and air dried.

CODE REFERENCE: 64E-11.003(2). Food shall only contact surfaces that are clean and sanitized.
