



# SMART INVESTMENTS LEAD TO SMART STUDENTS.

## FEBRUARY 2016 UPDATE

Broward County Public Schools is proud of the progress of the \$984 million SMART program, which includes funding from the \$800 million General Obligation Bond, plus \$184 million in existing capital resources. Below are the latest highlights.

### SMART Facilities Update

The District's Office of Facilities, with the SMART Cost and Controls Manager and Owner's Representative, is moving forward to implement the various components of the SMART program. Approximately 200 SMART projects are in progress, with more in planning.

Major SMART projects, with a combined cost of more than \$50 million, are also in the procurement phase at three of the District's high schools:

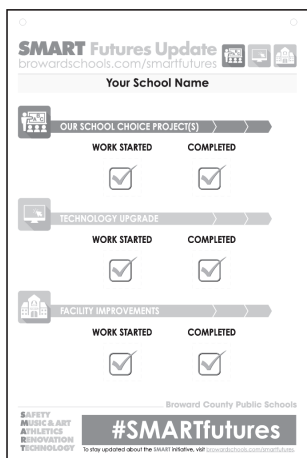

It's full speed ahead for the SMART Technology initiative. To date, **nearly 33,000 computer devices have been delivered and installed** at schools across the District.
